#### THE TANZANIA COURT OF APPEAL RULES

#### PART I PRELIMINARY PROVISIONS

Citation

**1.**-(1) These Rules may be cited as the Tanzania Court of Appeal Rules. (2) Omitted.

Administration of Rules G.N. No. 344 of 2019 r.2

2. In administering these Rules, the Court shall seek to give effect to the overriding objective as provided for under sections 3A and 3B of the Act.

Interpretation G.N.No. 344 of 2019 G.Ns. Nos. 36 of 2010 r.3 Cap.4 s.8 Cap.141

3. In these Rules, unless it is otherwise expressly provided or the context so requires otherwise-

"Act" means the Appellate Jurisdiction Act or any other Act amending or replacing it;

"advocate" means a person who, under rule 33, has a right of audience before the Court;

"appeal" in relation to appeals to the Court, includes an intended appeal;

"appellant" means a party appealing from a decision, decree or order of the High Court or tribunal and includes the legal practitioner retained or assigned to represent him in the proceedings before the Court;

"appellate jurisdiction" in relation to the High Court

includes its jurisdiction in matters of revision, review, reference, and point of law reserved;

"appointed day" means the First day of February, 2010;

"appropriate registry" has the meaning assigned to it by rule 6;

- "Chief Justice" means the Chief Justice of the United Republic of Tanzania and includes an Acting Chief Justice or a Justice of Appeal appointed under Article 118 of the Constitution to perform the duties of the Chief Justice;
- "Constitution" means the Constitution of the United Republic entitled "Katiba ya Jamhuri ya Muungano wa Tanzania, ya Mwaka 1977" and includes any amendment thereto or modification thereof or any enactment replacing it or the English translation, if any, of that Constitution published in the *Gazette*;
- "Court" means the Court of Appeal of the United Republic of Tanzania established by the Constitution, and includes any division of that Court and a single Judge exercising any power vested in him sitting alone;
- "Court appealed from" includes a Tribunal or any other judicial body from which an appeal is preferred to the Court;
- "Court vacation" means a Saturday, Sunday or a public holiday, including the 15<sup>th</sup> December to 31<sup>st</sup> January and from the second Saturday before Easter to the first Tuesday after inclusive, and any other day on which the Registry is closed;
- "Deputy registrar" means a deputy registrar of the Court, and includes any officer of the High Court appointed by the Chief Justice to be a deputy registrar of the Court;
- "High Court" has the meaning ascribed to it under section 3 of the Act and for the purposes of appeals to the Court, includes a subordinate court with extended jurisdiction from which an appeal may lie to the Court;

"Judge" means a Judge of the Court acting as such;

"Judgment" includes a decree, order, sentence or

determination of any Court, Tribunal, Judge or Judicial Officer;

"Judgment of the Court" includes any order made by the Court;

"Justice" means a Justice of the Court;

- "legal representative" means a person who in law represents the estate of a deceased person, and includes any person who intermeddles with the estate of the deceased and where a party sues or is sued in a representative character, the person on whom the estate devolves on the death of the party so suing or sued;
- "notice of appeal" in relation to a criminal appeal, means a notice lodged in accordance with rule 68, and, in relation to a civil appeal, means a notice lodged in accordance with rule 83;
- "notice of cross-appeal" means a notice lodged in accordance with rule 94;

"notice of grounds for affirming the decision" means a notice lodged in accordance with rule 100;

- "Presiding Justice" means, in relation to the hearing of any appeal or application or to the delivery of judgment on an appeal, the Presiding Justice of the Court as constituted for that appeal;
- "prison" means a prison established or deemed to have been established under section 23 of the Prisons Act, and includes any other place of detention to which any person may have been committed by a court;
- "record" means the aggregate of papers relating to an appeal or application (including the pleadings, proceedings, evidence, judgments and briefs) proper to be laid before the Court on the hearing of an appeal or application;

"Registrar" means the Registrar of the Court, and includes a deputy registrar of the court;

"Registrar of the High Court" means the Registrar of the

High Court or tribunal and includes a deputy registrar or acting deputy registrar of that court or tribunal;

- "Registry" means the Registry of the Court and, where one has been established, includes a sub-registry of the Court;
- "respondent", in relation to a civil application, includes any person on whom the notice of motion has been served and, in relation to a civil appeal, includes any person on whom a notice of appeal has been served and any person directly affected by the appeal, or on whom a notice of cross appeal has been served; and in criminal appeal means the person who undertakes the defense of the judgment appealed against and includes the legal practitioner retained or assigned to represent them in the proceedings before the Court;
- "Treasury" means the Treasury in the Ministry responsible for Finance;
- "trial judge" includes a magistrate exercising extended jurisdiction;
- "reference to a party to an appeal" includes the advocate acting for that party in the appeal, but an advocate shall not be deemed to be acting for a party by reason only of his having acted for that party in the proceedings from which the appeal is brought;
- "Rules" means these rules or any amendment thereto or any other additional Rules made thereto, and includes the Schedules appended to these Rules;
- "sub-registry" means every registry of the High Court and other such sub-registries of the Court established under the Tanzania Court of Appeal (Subregistries) (Establishment) Order.

#### PART II

### GENERAL ADMINISTRATIVE AND PROCEDURAL PROVISIONS

Practice and procedure of Court

**4**.-(1) The practice and procedure of the Court in connection with appeals, intended appeals and revisions from the High Court, and the practice and procedure of the Court in relation to review and reference; and the practice and procedure of the High Court and tribunals in connection with appeals to the Court shall be as prescribed in these Rules or any other written law, but the Court may at any time, direct a departure from these Rules in any case in which this is required in the interests of justice.

(2) Where it is necessary to make an order for the purposes of-

- (a) dealing with any matter for which no provision is made by these Rules or any other written law;
- (b) better meeting the ends of justice; or
- (c) preventing an abuse of the process of the Court,

the Court may, on application or on its own motion, give directions as to the procedure to be adopted or make any other order which it considers necessary.

Language of court

5. The language of the Court shall be either English or Kiswahili, as the Chief Justice may direct or as the case may be the Presiding Justice may direct, but the judgment, order or decision of the Court shall be in English.

**6**.-(1) The Registry shall be situated at Dar es Salaam, but where the Court is sitting or about to sit in any place other than Dar es Salaam, then, for the purposes of any application or appeal to be heard in that place, the Registry shall be deemed to be situated in that place.

(2) The Chief Justice may, by order published in the *Gazette*, establish such number of sub-registries in such places in Tanzania as he may determine.

Registry and sub-registries

Registrar	7. The Registrar appointed under the provisions of the Constitution shall be the chief administrative officer of the Court.
Computation of time	<ul> <li>8. Any period of time fixed by these Rules or by any decision of the Court for doing any act shall be reckoned in accordance with the following provisions- <ul> <li>(a) a period of days from the happening of an event or the doing of an act or thing shall be deemed to be exclusive of the day in which the event happens or the act or thing is done;</li> <li>(b) if the last day of the period is a court vacation, the period shall include the next following day not being a court vacation;</li> <li>(c) where, by these rules or by any order of the Court any step is required to be taken in connection with any cause, appeal or matter before the Court that step shall, unless the context otherwise requires, be taken in the Registry; and</li> <li>(d) where any particular number of days is prescribed by these rules, or is fixed by an order of the Court, in computing the same, the day from which the said period is to be reckoned shall be excluded, and, if the last day expires on a day when the Court is closed, that day and any succeeding days on which the Court remains closed shall also be excluded.</li> </ul> </li> </ul>
Court vacation	9. Save as is provided in rule 8, in computing time limited for any act or proceeding under these Rules a court vacation shall not be reckoned unless that day is the last day of that time, in which case it shall be excluded from that computation.
Extension of time	<b>10</b> . The Court may, upon good cause shown, extend the time limited by these Rules or by any decision of the High Court or tribunal, for the doing of any act authorized or required by these Rules, whether before or after the expiration of that time and whether before or after 24

the doing of the act; and any reference in these Rules to any such time shall be construed as a reference to that time as so extended.

**11**.-(1) A sentence of death or corporal punishment shall not be carried out until the time for giving notice of appeal has expired or, where notice of appeal has been given, until the appeal has been determined.

(2) Subject to the provisions of sub-rule (1), the institution of an appeal, shall not operate to suspend any sentence but the Court may in any criminal proceedings, where notice of appeal has been given in accordance with rule 68, order that the appellant be released on bail or that the execution of any warrant of distress be suspended pending the determination of the appeal.

(3) In any civil proceedings, where a notice of appeal has been lodged in accordance with rule 83, an appeal, shall not operate as a stay of execution of the decree or order appealed from nor shall execution of a decree be stayed by reason only of an appeal having been preferred from the decree or order; but the Court, may upon good cause shown, order stay of execution of such decree or order.

(4) An application for stay of execution shall be made within fourteen days of service of the notice of execution on the applicant by the executing officer or from the date he is otherwise made aware of the existence of an application for execution.

(4A) An application under subrule (4) shall be substantially in the Form K as specified in the First Schedule to these Rules.

(5) No order for stay of execution shall be made under this rule unless the Court is satisfied that-

- (a) substantial loss may result to the party applying for stay of execution unless the order is made;
- (b) security has been given by the applicant for the due performance of such decree or order as may ultimately be binding upon him.

(6) Notwithstanding anything contained under subrule (5) of this rule and rule 60 (2) (b), a single Justice of the Court may, for good cause, make an *ex parte* order for stay of execution pending hearing and determination of the application.

(7) An application for stay of execution shall be accompanied by copies of the following-

(a) a notice of appeal;

(b) a decree or order appealed from;

(c) a judgment or ruling appealed from; and

(d) a notice of the intended execution.

Form of documents for use in proceedings of Court G.N. Nos. 148 of 2018 344 of 2019 r.5 Cap. 4 s.8 **12**.-(1) Except where the nature of the document renders it impracticable, every document prepared for use in the Court shall be on paper of durable quality, and shall be clear and easily legible and may be produced by computer, printing, lithography, stencil duplicating, photography, xerography, typewriting, electronically generated or any combination of these media.

(2) Where these Rules requires the filing of a document in the Court, that document may be filed electronically and the Judicature and Application of Laws (Electronic Filing) Rules, shall apply *mutatis mutandis*.

(3) In every criminal appeal, the record of appeal and, in every civil appeal, the memorandum of appeal together with the record of appeal, shall be bound in book form with a cover of stout paper and may be in volumes more than one, and the title of the appeal shall appear on the cover.

(4) The pages of every application and, in criminal cases, of the record of appeal, and in civil cases, of the memorandum of appeal and the record of appeal shall be numbered consecutively.

(5) In all applications and appeals, every tenth line of each page of the record shall be indicated in the margin on the right side of the sheet.

(6) Whatever medium is adopted for the production and reproduction of documents for use in the Court, the taxing officer shall on taxation allow only those costs which would in his opinion have been incurred by using the most economical method permitted or available.

Powers and functions of Registrar or Registrar of High Court

**13**.-(1) The Registrar shall have the custody of the records of the Court and shall exercise such other functions as are assigned to him by these Rules.

(2) The Chief Justice may assign and the Registrar may, with the approval of the Chief Justice, delegate, to a Deputy Registrar, any function required by these Rules to be exercised by the Registrar.

(3) In the absence of the Registrar, the Deputy Registrar may exercise all the functions of the Registrar.

(4) The official seal to be used in the Court shall be such as the Chief Justice may from time to time direct, and shall be kept in the custody of the Registrar.

(5) The Seal of the Court shall not be affixed to any certified copy issued by the Court save under the authority in writing of the Registrar or of a Deputy Registrar.

(6) The Registrar shall keep a list of all cases pending before the Court and shall-

- (a) at the commencement of each session of the Court, prepare and publish on the Notice Board of the Court a list of all the cases ready for hearing in each class separately, to be called the "cause list"; and
- (b) the cases in the cause list shall be arranged year-wise in each class separately in the order of their registration and the list may be added to from time to time.

(7) In addition to the powers conferred by other rules, the Registrar shall have the following duties and powers subject to any general or special direction of the Chief Justice, namely-

- (a) to require any memorandum of appeal or application or other proceeding presented to the Court to be amended in accordance with the practice and procedure of the Court or rules of the Court thereto and ensure that the directions are complied with;
- (b) to fix the date of hearing of appeals, application and other proceedings and issue notices thereof;
- (c) to direct any formal amendment of record;
- (d) to settle the index in cases where the record is prepared in the Court;
- (e) to make an order for change of an advocate on record with the consent of the advocate on record;
- (f) to grant leave to inspect and search the records of the Court and order the grant of copies of documents to parties to proceedings; and without interfering or dispensing with the mandatory requirement of these Rules;
- (g) to allow from time to time as prescribed in these Rules, on a written request, time to furnish information or of doing any other act necessary to bring the appeal, application or other proceeding in conformity with the rules and practice of the Court.

Acceptance and rejection of documents G.N. No. 362 of 2017 r.3. 14.-(1) Whenever a document is lodged by a party in the Registry or sub registry of the Court in accordance with these Rules, the Registrar shall accept such a document and stamp it showing the date and time it was lodged and if a party so requests shall similarly endorse any copy submitted for that purpose.

(2) For purposes of the provisions of sub-rule (1), documents to be lodged with the Registrar shall include, inter alia: a notice of appeal; notice of motion; notice to withdraw a notice of appeal; notice to withdraw an appeal; notice of preliminary objection; memorandum of appeal and record of appeal. (3) The Registrar, Registrar of the High Court or tribunal or deputy registrar thereof, as the case may be, may refuse to accept any document which does not comply with the requirements of rule 12 or which is defective in other aspects.

(4) Where the Registrar refuses to accept a document which does not comply with the requirements of these Rules or any other law, he shall inform the party concerned in writing, directing what amendments or adjustments to be made and shall fix the time within which the documents may be filed.

(5) Where the Registrar directs a party to amend or adjust a document, the party shall lodge the amended or adjusted document within seven days notwithstanding that such period may go beyond the time prescribed by the law for filing such documents.

(6) Subject to the provisions of rules 126 and 128, the Registrar or the Registrar of the High Court or tribunal, as the case may be, shall not accept any document tendered without the required fee, if any, or in the case of the memorandum of appeal in a civil appeal, the lodging of security for costs.

(7) Where as a result of an error, a document is accepted which ought to have been rejected under sub rule (6) of this rule, the document shall be deemed to have been duly lodged but the person who lodged it shall, as soon as practicable after the error is discovered, pay the required fee or the balance of it or lodge the required security.

(8) Entries in the register and endorsements made as provided for in this rule shall be deemed authentic.

(9) Any other person having an interest in any matter before the Court may, on payment of an appropriate fee, inspect the register, documents, record of proceedings, and obtain certified copies of the judgment or orders.

(10) Any person aggrieved by any order or a decision made by the Registrar or Deputy Registrar under this rule may, within fourteen days of the making of such order, require the matter to be referred to a Judge in

Chambers for his decision. An application under this sub rule may be made informally at the time when the decision is given or in writing within fourteen days after the decision.

15. Except during vacation and on saturdays and holidays, offices of the registry of the Court and its sub registries shall, subject to any direction by the Chief Justice, be open daily from nine O'clock in the forenoon to One O'clock in the afternoon.

**16.**-(1) Notwithstanding the appointment of any appropriate registry by or under these Rules as the place where any document is to be lodged, the Registrar may in any particular case permit the lodging of any document in the Registry or in any sub-registry and an application for such permission may be made informally but shall be in writing.

(2) The Registrar or a deputy registrar receiving a document so lodged shall forthwith send it to the appropriate registry at the expense of the applicant, except where the document is lodged with the Registrar and is one which, if lodged in the appropriate registry, may have been required by these Rules to be sent to the Registrar.

**17.**-(1) Any document may be signed on behalf of the person making it by any person entitled under rule 30 to appear on his behalf.

(2)In or in relation to criminal appeals, a document may be signed on behalf of an appellant who is alleged to be of unsound mind by a person entitled under Rule 30 to appear on his behalf or by any person in whose care that person may be for the time being, including a medical officer, a police or prison officer.

Endorsement of Whenever any document is lodged in the 18. documents Registry, sub-registry of the Court, or in the registry of the High Court, or tribunal under or in accordance with these Rules, the Registrar, or Deputy Registrar, or the Registrar

of the High Court or any other officer of the court appointed for that purpose, as the case may be, shall forthwith cause it to be endorsed, showing the date and time when it was lodged.

**19**.-(1) Subject to the directions of the Chief Justice on numbering of applications, every application to the Court other than an application made informally in the course of a hearing shall, whether lodged before or after the institution of an appeal, be given a serial number and for this purpose there shall be maintained in the Registry and in each sub-registry two series of numbers for each calendar year, one for criminal and one for civil applications and the serial number shall be prefixed by letters indicative of the Registry or sub-registry.

(2) Every criminal appeal shall be given a serial number in the Registry, which shall be allotted as soon as the notice of appeal is received, and for this purpose a series of numbers shall be maintained for each calendar year.

(3) Every civil appeal shall be given a serial number in the registry, which number shall be allotted as soon as the memorandum of appeal is received and for this purpose a series of numbers shall be maintained for each calendar year.

Form of amendments

**20**.-(1) Where any person obtains leave to amend any document, the document itself may be amended or if it is convenient, an amended version of the document may be lodged.

(2) Where any person lodges an amended version of a document, he shall show clearly-

- (a) any words or figures deleted from the original, by including those words or figures and striking them through with red ink, by use of computer technology or any other electronically recognized means of showing changes so that what was written remains

legible;

(b) any words or figures added to the original, by writing them in red ink or underlining them in red ink or by use of computer technology.

(3) Where any record of appeal includes any amended document, the amendments shall similarly be shown in each copy of the record of appeal.

Maintenance of registers

21.-(1) The Registry shall maintain-

- (a) a register of criminal applications, in which shall be entered particulars of every application lodged in the Registry or sent to the Registrar by any deputy registrar relating to a criminal appeal;
- (b) a register of civil applications, in which shall be entered particulars of every application lodged in the Registry or sent to the Registrar by any deputy registrar relating to a civil appeal;
- (c) a register of criminal appeals, in which shall be entered particulars of every notice of appeal lodged in any criminal matter and of the subsequent proceedings; and
- (d) a register of civil appeals, in which shall be entered particulars of every notice of appeal lodged in any civil matter and of the subsequent proceedings.

(2) Every deputy registrar in charge of a sub-registry shall maintain-

- (a) a register of criminal applications, in which shall be entered particulars of every application lodged in his sub-registry relating to a criminal appeal; and
- (b) a register of civil applications, in which shall be entered particulars of every application lodged in his sub-registry relating to a civil appeal.

(3) The registers maintained under this rule shall show the number of the application or appeal, the number of the proceedings in the High Court, the names of the parties, the dates when the essential steps in the proceedings were taken and the result of the application or appeal; but registers maintained in a sub-registry need not show the result of applications, but shall show the dates when the material documents were sent to the Registrar.

(4) The registers of criminal and civil appeals shall in addition contain against the entry relating to each appeal a reference to every application made in relation to that appeal, whether made before or after the institution of the appeal.

(5) Any interested person or member of the public may with the permission of the Registrar or deputy registrar, obtain access to the register and take copies of any entries, order or decision of the court upon payment of a prescribed fee.

Process of Court and service

Cap. 33

22.-(1) Subject to the provisions of these Rules, where any document is required to be served on any person, service may be effected in accordance with the procedure and practice of the High Court under the provisions of the Civil Procedure Code read together with the provisions of these Rules or such other way as the Court may in any case direct.

(2) In the absence of any special direction, service shall be made personally on the person to be served or any person entitled under rule 30 to appear on his behalf; but where a party to any proceeding has given an address for service, service may be effected by delivery at that address.

(3) Where any document is required to be served on the appellant or on the respondent, or on two or more appellants or respondents as the case may be, represented by one advocate, it shall be sufficient if one copy of that document is served on that advocate.

- (4) For the purpose of this rule, service on a
  - 33

partner or a clerk of an advocate at the office of the advocate shall be deemed to be service on the advocate.

(5) Where any person out of the jurisdiction of the Court is a necessary or proper party to a proceeding the Court may allow service out of the jurisdiction of any document required to be served upon that party or that notice of that document be served in lieu of the document.

(6) Proof of service may be given where necessary by affidavit, unless in any case the Court requires proof by oral evidence.

(7) Where the person to be served is in prison, service may be effected by transmitting the document to the officer in charge of the prison for delivery to the prisoner, and service on the prisoner may be proved by a letter purporting to be signed by the officer in charge of the prison and certifying that the document was delivered to the prisoner on a specified date.

(8) Where any document is required to be sent to any person, the document may be sent by hand or by registered post to that person or to any person entitled under Rule 30 to appear on his behalf and notice of the date fixed for the hearing of an application or appeal or for the delivery of judgment or the reasons for any decision may be given by telephone or telegram.

(9) Whereby these Rules a party is required to serve any document on another party within a limited time, and by virtue of this rule or any other written law or order of the Court that document is required to be served by or through a process server or other officer of any court, the party shall be deemed to have served the document in due time if within the time limited for service he files the document in the Registry together with any necessary copies and a requisition for service and pays all fees and charges payable in respect of it, but if the party is required to assist the officer by identifying the person to be served or otherwise, he shall do so with all due diligence and in default of so doing shall be deemed to have failed to serve the other party in due time.

**25**.-(1) The Court shall sit and appeals shall be heard by the Court, in such places in the United Republic as the Chief Justice may from time to time determine.

(2) The sittings of the Court and the matters to be disposed of at those sittings shall be advertised and notified in such manner as the Chief Justice may direct, but the Court may at any sitting, dispose of any matter or business which has not been advertised or notified.

Business during vacations

**26.**-(1) The vacations of the Court and the arrangement for business during vacations shall be determined by the Chief Justice and shall be advertised and notified in such manner as he may direct.

(2) No business may be conducted during vacations, unless the Chief Justice directs otherwise, except the delivery of judgment and when the matter is shown to be of urgency, the hearing of applications and the taxation of bills.

(3) A certificate of urgency shall not be granted unless justified by the special circumstances of the case or serious hardship.

Composition of Court at sitting

27. Save where a matter is dealt with by a single Justice, for the purpose of hearing any appeal or application, the Court shall consist of three Justices selected by the Chief Justice for that purpose.

Power of single Justice

28. A single Justice may exercise any power vested in the Court, which does not involve the decision of an appeal, revision, reference, review or any other proceeding whose determination requires the full Court, but if any Justice rejects any application for the exercise of the power, the person making that application shall be entitled to have his application determined by the Court.

Appeals to be heard in court

**29**.-(1) Subject to sub-rules (2) and (3), every appeal shall be heard in court to which all members of the public shall have access so far as space in the court permits and so long as they conduct themselves in an orderly manner.

(2) The Presiding Justice may, if in exceptional circumstances he is satisfied that the interests of justice so require, direct that the public or any particular person or category of persons be excluded or removed from the court in which an appeal is being heard.

(3) No child other than an infant in arms shall be permitted to be present in court during the hearing of any appeal, or during any proceedings preliminary to the hearing, except during such time as his presence is required as a witness or for other purposes of justice, and where any child is in court contrary to this sub-rule, he shall be ordered to be removed.

(4) Nothing in this rule shall be construed so as to prejudice other inherent powers of the Court to hear proceedings in camera.

**30**.-(1) Subject to the provisions of rules 31 and 33, a party to any proceedings in the Court may appear in person or by advocate.

(2) A person not resident of the United Republic may appear by lawfully authorised attorney.

(3) A corporation may appear either by advocate or by its director or manager or secretary, who is appointed by resolution under the seal of the company, a sealed copy of which shall be lodged with the Registrar.

(4) Any person under disability may appear by advocate or by his committee, next friend or guardian *ad litem* as the case may be.

(5) Where any person has acted as next friend or guardian *ad litem* in the court below for a person under disability and the person under disability becomes respondent in an appeal to the Court, the next friend or guardian *ad litem* may, if he desires to act as such in the appeal, lodge a consent to act as such and shall thereupon be deemed to have been duly appointed:

Provided that, in any other case, the Court may-

- (a) appoint a guardian *ad litem* for the purpose of an appeal; or
- (b) at any time remove and replace any guardian *ad litem*, however appointed.

(6) An advocate who intends to withdraw from representing his client, shall, within 14 days before the hearing date, lodge a notice of withdrawal and furnish the Registrar with the address of service of his client.

Assignment of advocates

**31**.-(1) In any criminal application or appeal, the Chief Justice or the Presiding Justice may at any time assign an advocate to represent an applicant or appellant if it appears desirable in the interests of justice.

(2) In any civil appeal involving a point of law of public importance, if the Chief Justice is satisfied that any appellant or respondent lacks the means to employ an advocate, he may, with the consent of that appellant or respondent, as the case may be, assign an advocate to represent him and may require that appellant or respondent, as a condition of having an advocate assigned to him, to undertake to refund the fees and expense of the advocate out of any money or property he may recover in or in consequence of the appeal.

(3) The fees and expenses of an advocate assigned under the provisions of sub-rule (1) or sub-rule (2) shall be as set out in the Fourth Schedule to these Rules and the same shall be defrayed out of the funds of the court:

Provided that, the Chief Justice may, in special

circumstances, direct that higher fees be paid.

(4) The Registrar may take such action as he may think necessary to enforce any undertaking given in accordance with sub-rule (2) and any moneys so recovered shall be paid into the Consolidated Fund.

**32.**-(1) Where any party to an application or appeal changes his advocate or, having been represented by an advocate, decides to act in person or, having acted in person engages an advocate, he shall, as soon as practicable, lodge with the Registrar notice of the change and shall serve a copy of the notice on the other party appearing in person or separately represented, as the case may be.

(2) Upon receiving notification of change of an advocate, the Registrar shall record the changes accordingly and bring it to the attention of the Presiding Justice.

Right of audience of advocates

**33**.-(1) The Attorney-General or the Director of Public Prosecutions when appearing as such in any application or appeal, whether of his own motion or at the instance of the Court, shall have the right of audience in the Court and shall take precedence over all other advocates; but where only the Attorney-General appears as such, the Attorney-General shall take precedence.

(2) The provisions of sub rule (1) shall apply in relation to the Deputy Attorney General, Law Officers and State Attorneys appearing in court on behalf of the Attorney General.

(3) No advocate shall have the right of audience in the Court unless he has practiced for a period of not less than five years in the High court and courts subordinate thereto:

Provided that, an advocate who has not practiced for five years in the High Court and Courts subordinate may apply for a waiver in a particular matter in writing to the Chief Justice or Presiding Justice, as the case may be,

and shall be made within a period of not less than seven days to the date of hearing of the particular matter, showing good grounds for seeking the waiver.

(4) Any other person entitled to appear as counsel or advocate before any court of unlimited jurisdiction in any country in the Commonwealth shall, if licensed in that behalf by the Chief Justice and subject to payment of the prescribed fee, have the right of audience before the Court in respect of any one appeal or application, including any cross-appeal heard with it, or any two or more appeals or applications consolidated for hearing.

**34.**-(1) An advocate who intends, at the hearing of any application or appeal, to rely on a judgment in any reported or unreported case or to quote from any book shall lodge with the Registrar at the place where the application or the appeal is to be heard, eight copies of the list containing the titles and shall attach extracts of the relevant pages of the book or article or copies of the case or cases with their citations and the names, authors and editions of the book or books, and shall serve copies of that list on the other party or on each other party appearing in person or separately represented, as the case may be.

(2) The list of authorities under sub-rule (1) shall be-

- (a) in the case of an appeal, a minimum of eight copies or such other number as the circumstances of the case may require; or
- (b) in the case of an application, a minimum of four copies or such other number as the circumstances of the matter may require.

(3) The list of authorities under this rule shall be lodged at least three working days before the appeal or application is due to be heard.

(4) An advocate who intends at the hearing of an application or appeal, to rely on a judgment in any unreported case or decision from a foreign jurisdiction shall, at the time of filing the list of authorities, produce and attach eight certified or photostat copies of that judgment and, except in the case of an application to be

heard by a single Justice, other copies of it for the use of the Court, and in every case, one copy for the use of the other party, or each other party appearing in person or separately represented, as the case may be.

Order of addresses

35.-(1) The Court shall, subject to any other rule to the contrary, at the hearing of an application or appeal, hear first the applicant or appellant, then the respondent and then the applicant or appellant in reply, as the case may be.

(2) At the hearing of an appeal where notice of a cross-appeal has been given, the Court will ordinarily hear the appellant first on the appeal, then the respondent on the appeal and on the cross-appeal, then the appellant in reply on the appeal and on the cross-appeal and finally the respondent in reply on the cross-appeal.

(3) The Court may dismiss but shall not allow any preliminary objection, application, appeal or cross-appeal without calling on the opposing party.

(4) After hearing the opposing party, the Court may allow but shall not dismiss any preliminary objection, application, appeal or cross-appeal without giving the objector, applicant, appellant or cross-appellant an opportunity to reply.

(5) The provisions of this rule shall apply where notice of grounds for affirming the decision has been given, in the same way in all respects as where notice of cross-appeal has been given.

**36**.-(1) On any appeal from a decision of the High Court or Tribunal acting in the exercise of its original jurisdiction, the Court may—

- (a) re-appraise the evidence and draw inferences of fact; and
- (b) in its discretion, for sufficient reason, take additional evidence or direct that additional evidence be taken by the trial court or by a commissioner.

Power to reappraise evidence and to take additional evidence

(2) When additional evidence is taken by the Court, it may be oral or by affidavit and the Court may allow the cross-examination of any deponent.

(3) When additional evidence is taken by the trial court, it shall certify such evidence to the Court, with a statement of its own opinion on the credibility of the witness or witnesses giving the additional evidence, when evidence is taken by a commissioner, he shall certify the evidence to the Court without any statement of his own opinion on the credibility of the witness or witnesses.

(4) The parties to the appeal shall be entitled to be present when any additional evidence is being taken but that evidence shall not be taken on the presence of any assessor.

Power to call **37**. In dealing with any appeal before it, the Court may, if it thinks fit call for and receive from the trial court a report on any matter connected with the trial proceedings.

General powers of Court

**38**. The Court may, in dealing with any appeal so far as its jurisdiction permits, confirm, reverse or vary the decision of the High Court or Tribunal or remit the proceedings to the High Court or Tribunal with such directions as may be appropriate, or to order a new trial, and to make any necessary incidental or consequential orders including orders as to costs.

Adjournment G.N. No. 344 of 2019 r.7 **38A**.-(1) The Court may, upon good cause shown, adjourn the hearing of an appeal or application upon such terms and conditions as to costs as it may deem fit.

(2) No adjournment shall be granted at the request of a party or parties except where the circumstances are beyond the control of the party or parties as the case may be.

(3) The fact that an advocate of a party is engaged in another court shall not be a ground for adjournment unless that advocate is appearing before a superior panel and informs the Registrar in advance at least one week

before the date of hearing.

(4) Where illness of an advocate or his inability to conduct the case for any reason other than his being engaged in another court is put forward as a ground for adjournment, the Court shall not grant adjournment unless it is satisfied that the party applying for adjournment could not have engaged another advocate in time.

(5) In the event of an adjournment at the instance of the Court, the reason for the adjournment shall be recorded and the Court shall strive to fix the hearing date within the shortest period possible.

**39**.-(1) At the close of the hearing of an application or appeal, the Court may give its judgment at once or reserve it for delivery within 90 days unless the court for reasons to be recorded orders otherwise.

(2) In criminal applications and criminal appeals, a judge may write a separate judgment and shall be required to sign the judgment, and in any particular case, the presiding Judge may direct that separate judgments be given.

(3) In civil applications and civil appeals separate judgments shall be given by the members of the Court unless, the decision being unanimous, the presiding Judge directs otherwise.

(4) Subject to sub-rule (5), the judgment or judgments of the Court on an application shall, where the application was heard in chambers be delivered in chambers, and the judgment or judgments on an application heard in court and the judgment or judgments on an appeal shall be delivered in court.

(5) The presiding Judge may, in any particular case, direct that only the decision of the Court and not the reasons for it shall be delivered in chambers or in court, and in that case the judgment or judgments shall be deposited in the Registry or sub-registry in the place where the application or the appeal was heard and copies of the judgment or judgments shall be made available to the parties when the decision is delivered.

(6) Notwithstanding the provisions of sub-rule (1), the Court may at the close of the hearing of an application

or appeal, give its decision but reserve its reasons and in such a case the reasons may be delivered in court or deposited in the Registry or sub-registry in the place where the application or appeal was heard and where the reasons are so deposited, copies of those judgments shall be available to the parties and they shall be so informed.

(7) Where one judgment is given as the judgment of the Court at the close of the hearing, it shall be delivered by the Presiding Justice or by such other member of the Court as the Presiding Justice may direct.

(8) Where the judgment, or the reasons for a decision, has been reserved, the judgment of the Court, or a judgment of any Judge or reasons, as the case may be, being in writing and signed, may be delivered by any Justice, whether or not he sat at the hearing or by the Registrar.

(9) A judgment or ruling shall be signed and dated as of the date it is finally composed and shall take effect from the date it is delivered and certified by the Registrar in the following words-

"The judgment/ruling delivered this ...day of...... 20... in the presence of the and is hereby certified as a true copy of the original."

(10) In order to facilitate the prompt disposal of applications and notwithstanding the preceding provisions of this rule, the Court may make orders without detailed reasoned ruling, especially in cases where the Court's decision-

- (a) is not potentially precedent-setting; or
- (b) does not require the interpretation of a rule, statute or common law.

(11) Where one of the members of the Court dies, ceases to hold office or is unable to perform the functions of his office by reason of infirmity of the mind or body, the remaining members, if -

(a) after considering the facts of the appeal or matter before them have concurring opinion, shall deliver the judgment; or

(b) they do not concur, the matter shall be referred to the Chief Justice for constituting another panel to conduct a fresh hearing.

**40**.-(1) Every decision of the Court on an application or appeal other than a decision on an application made informally in the course of a hearing shall be embodied in a formal order prepared by the Registrar.

(2) Every order shall be dated as of the date on which the decision was delivered and shall in addition show the date on which the order was extracted.

(3) An order on an application shall be substantially in the Form I set out in the First Schedule to these Rules and an order on an appeal substantially in the Form J in that Schedule.

**41**.-(1) Where a decision of the Court was given in a criminal or civil appeal, the formal order shall be drawn up by the Registrar who, in doing so, shall not be required to consult the parties to the application or appeal, or their advocates.

(2) A party seeking to contest the content of the formal order shall refer the matter in writing to the Presiding Justice and the decision of the Presiding Justice shall be final.

(3) The reference to the Justice shall be lodged within seven days from the service or obtaining of a copy of the order sought to be challenged.

Correction of errors

42.-(1) A clerical or arithmetical mistake in any judgment of the Court or any error arising in it from an accidental slip or omission may at any time, whether before or after the judgment has been embodied in an order, be corrected by the Court, either of its own motion or on the application of any interested person so as to give effect to what the intention of the Court was when judgment was given.

(2) An order of the Court may at any time be

corrected by the Court, either of its own motion or on the application of any interested person if it does not correspond with the judgment it purports to embody or where the judgment has been corrected under sub-rule (1), with the judgment as corrected.

(3) Where a party applies for the correction of an order of the Court, the court shall not enter the correction unless the other parties have been notified of the content of the intended correction and afforded an opportunity of being heard.

Notification of decisions

**43**.-(1) The Registrar shall send to the Registrar of the High Court or tribunal, a sealed copy of the order embodying the decision of the Court in any civil or criminal appeal from that court.

(2) The Registrar shall, so far as is practicable, inform any party to any proceeding in the Court who was not present or represented at the hearing of the result of such proceeding.

(3) A deputy registrar shall send to the Registrar a copy of every order issued out of his sub-registry.

(4) A deputy registrar shall send to the court of first instance or trial court a copy of the judgment.

### PART III APPLICATIONS

**44.**-(1) In criminal matters-

- (a) where an appeal lies with the leave of the Court, application for leave shall be made in the manner prescribed by rules 49 and 50;
- (b) where an appeal lies if the High Court certifies that a point of law is involved, application for that certificate may be made informally and *ex parte*.

(2) An application under this rule shall be made within fourteen days from the date when the notice of appeal is lodged.

- (a) notwithstanding the provisions of rule 46(1), where an appeal lies with the leave of the High Court, application for leave may be made informally, when the decision against which it is desired to appeal is given, or by chamber summons according to the practice of the High Court, within thirty days of the decision; or
- (b) where an appeal lies with the leave of the Court, application for leave shall be made in the manner prescribed in rules 49 and 50 and within fourteen days of the decision against which it is desired to appeal or, where the application for leave to appeal has been made to the High Court and refused, within fourteen days of that refusal; Provided that, in computing the time within

which to lodge an application for leave in the Court under paragraph (b), there shall be excluded such time as may be certified by the Registrar of the High Court as having been required for preparation of a copy of the decision subject to the provisions of rule 49(3).

**45A**.-(1) Where an application for extension of time to:-

(a) lodge a notice of appeal;

(b) apply for leave to appeal; or

(c) apply for a certificate on a point of law,

is refused by the High Court, the applicant may within fourteen days of such decision apply to the Court for extension of time.

(2) In computing the time within which to lodge an application under this rule, there shall be excluded such time as may be certified by the Registrar of the High Court as having been required for preparation of a copy of the

decision and the order.

(3) Every application under sub-rule (1) shall be accompanied by a copy of the decision against which it is desired to appeal and where application has been made to the High Court for extension of time and refused, by a copy of the refusal order.

Order of application and notice of appeal

46.-(1) Where an application for a certificate or for leave is necessary, it shall be made after the notice of appeal is lodged.

(2) Where any criminal appeal involves a certificate or leave and the appellant is in prison and unrepresented by an advocate, the High Court or the court shall, when passing sentence or any other order upon the appellant, call for the appellant to be produced in court to make his or her own application, and ascertain whether or not the appellant shall be granted the certificate or leave or may adjourn the decisions for the appellant to place all necessary facts before the court.

Applications in first instance

47. Whenever application is made either to the Court or to the High Court, it shall in the first instance be made to the High Court or tribunal as the case may be, but in any criminal matter the Court may in its discretion, on application or of its own motion give leave to appeal or extend the time for the doing of any act, notwithstanding the fact that no application has been made to the High Court.

Form of applications to Court G.N.Nos. 362 of 2017 r.8 344 of 2019 r.9 **48**.-(1) Subject to the provisions of sub-rule (3) and to any other rule allowing informal application, every application to the Court shall be by notice of motion supported by affidavit and shall cite the specific rule under which it is brought and state the ground for the relief sought:

Provided that where an application omits to cite any specific provision of the law or cites a wrong provision, but the jurisdiction to grant the order sought exists, the irregularity or omission can be ignored and the

Court may order that the correct law be inserted.

(2) A notice of motion shall be substantially in the Form A in the First Schedule to these rules and shall be signed by or on behalf of the applicant.

(3) The provisions of this rule shall not apply-

- (a) to applications made in the course of hearing, which may be made informally; or
- (b) to applications made by consent of all parties, which may be made informally by letter.

**49**.-(1) Every formal application to the Court shall be supported by one or more affidavits of the applicant or of some other person or persons having knowledge of the facts.

(2) An applicant may, with the leave of the Court or with the consent of the other party, lodge one or more supplementary affidavits, and an application for such leave may be made informally.

(3) Every application for leave to appeal shall be accompanied by a copy of the decision against which it is desired to appeal and where application has been made to the High Court for leave to appeal by a copy of the order of the High Court.

**50**.-(1) Whenever formal application is made to the Court for leave to amend any document, the amendment for which leave is sought shall be set out in writing and, if practicable, lodged with the Registrar and served on the respondent before hearing of the application or, if that is not practicable, handed to the Court and to the respondent at the time of the hearing.

(2) Where the Court gives leave for the amendment of any document, whether on a formal or an informal application, the amendment shall be made or an amended version of the document be lodged within such time as the Court when giving leave may specify and if no time is so specified then within forty-eight hours of the

giving of leave and on failure to comply with the requirements of this sub-rule, the leave so given shall cease to have effect.

**51.**-(1) An application to the Court shall be lodged in the appropriate registry, save where the matter is one of urgency, in which case it may be lodged in the Registry, even if it is not the appropriate registry.

(2) A certificate of urgency shall set grounds showing a *prima-facie* case of the special circumstances or serious hardship faced by the applicant and not merely expedience.

**52**. When an application to be heard by a single Justice is lodged in a sub-registry, the deputy registrar shall send it to the Registrar, together with the original record.

**53**.-(1) An application which the applicant desires to be set down for hearing during a vacation shall be accompanied by a certificate of urgency signed by the applicant or his advocate.

(2) A certificate of urgency shall set the grounds explaining the exceptional circumstances of the matter, which *prima facie* establish good cause for an urgent and not merely expedient, hearing of the matter.

(3) In determining the urgency of the matter, the Chief Justice shall consider, *inter alia*, the time taken to file the certificate in the light of the occurrence of the event; the special circumstances of the matter; the seriousness of the hardship to the applicant and adequacy of the grounds set forth.

**54**.-(1) Whenever an application is made to the Court, the applicant shall file a minimum of eight copies of the application together with similar number of copies of other documents relating to it.

(2) Where the application is to be heard by a single Justice, the application and other documents relating to it shall be filed in quadruplicate.

(3) When an application is adjourned by a single

**55**.-(1) The notice of motion, affidavit and all supporting documents shall, within fourteen (14) days from the date of filing, be served upon the party or parties affected.

(2) Notwithstanding the provisions of sub-rule (1), in case of urgency, an application, other than an application under rule 128, may be made *ex parte*, but in that case, if the applicant is represented by an advocate, the advocate shall sign a certificate of urgency, which shall be filed with the proceedings.

(3) Where any person required to be served with a notice of motion gave an address for service in or, in connection with the proceedings in the superior court and has given no subsequent address for service, the notice may be served on him at that address, notwithstanding that it may be that of an advocate who has not been retained for the purpose of any subsequent proceedings.

Affidavits in reply

**56**.-(1) Any person served with a notice of motion under rule 54 may lodge one or more affidavits in reply and shall as soon as practicable, serve a copy or copies of the affidavit or affidavits on the applicant.

(2) Any such person may, with the leave of a Justice or with the consent of the applicant, lodge one or more supplementary affidavits, and application for leave to do so may be made informally.

(5) Any person claiming to be the legal representative of a deceased party or any other interested person, may apply to revive the application; and, if it is proved that he was prevented by good cause from continuing the application, the Court shall revive the application upon such terms as to costs or otherwise as it deems fit.

- (c) an application to strike out a notice of appeal or an appeal; or

(2) Where the applicant appears and the respondent fails to appear, the application shall proceed in the absence of the respondent, unless the Court sees fit to adjourn the hearing.

(3) Where an application has been dismissed under sub-rule (1) or allowed under sub-rule (2), the party in whose absence the application was determined may apply to the Court to restore the application for hearing or to rehear it, as the case may be, if he can show that he was prevented by any sufficient cause from appearing when the application was called on for hearing.

(4) An application made under sub-rule (3) shall be made within thirty days of the decision of the Court or in the case of a party which has been served with notice of the hearing but was not so served, within thirty days of his first hearing of that decision.

(5) The provisions of sub-rule (1) shall not apply to any criminal application if the applicant is in prison and is not represented by an advocate, and in that case the application shall be heard notwithstanding the absence of the applicant, unless the Court orders otherwise.

Rescinding of orders

**64.**-(1) An order made on an application heard by a single Justice may be varied or rescinded by that Justice or any other Justice or by the Court on the application of

any person affected by it, if -

- (a) the order was one extending the time for doing any act, otherwise than to a specific date; or
- (b) the order was one permitting the doing of some act, without specifying the date by which the act was to be done, and the person on whose application the order was made, has failed to show reasonable diligence in the matter.

(2) An order made on an application to the Court may similarly be varied or rescinded by the Court.

# PART IIIA REVISION

Institution of revision

**65**.-(1) Save where a revision is initiated by the Court on its own accord, an application for revision shall be by notice of motion which shall state the grounds of the application.

(2) The notice of motion shall be signed by or on behalf of the applicant.

(3) The notice of motion shall be supported by one or more affidavits of the applicant or some other person or persons having knowledge of the facts.

(4) Where the revision is initiated by a party, the party seeking the revision shall lodge the application within sixty days (60) from the date of the decision sought to be revised.

(5) The Notice of motion and affidavits shall be served on the respondent within fourteen days from the date of filing and the party filing the notice shall file proof of service with the Court.

(6) Where the application is initiated by the Court on its own accord, the Court shall have discretion to summon the parties and shall grant the parties an opportunity to address the court.

(7) Every application for revision shall be heard by the Court.

#### PART IIIB REVIEW

Institution of review Cap. 4 s.8 **66**.-(1) The Court may review its judgment or order, but no application for review shall be entertained except on the following grounds -

- (a) the decision was based on a manifest error on the face of the record resulting in the miscarriage of justice;
- (b) a party was wrongly deprived of an opportunity to be heard;
- (c) the court's decision is a nullity; or
- (d) the court had no jurisdiction to entertain the case;
- (e) the judgment was procured illegally, or by fraud or perjury.

(2) An application for review shall, subject to necessary modifications, be instituted in the same mode as a revision.

(3) The notice of motion for review shall be filed within sixty days from the date of the judgment or order sought to be reviewed and it shall set out clearly the grounds for review.

(4) Copies of the notice of motion for review shall be served on the other party or parties as the case may be within fourteen days from the date of filing and the party filing the notice shall file proof of service with the court

(5) An application for review shall as far as practicable be heard by the same Justice or Bench of Justices that delivered the judgment or order sought to be reviewed.

(6) Where the application for review is granted, the court may rehear the matter, reverse or modify its former decision on the grounds stipulated in sub-rule (1) or make such other order as it thinks fit.

- (7) Where an application for review of any

judgment and order has been made and disposed of, a decision made by the court on the review shall be final and no further application for review shall be entertained in the same matter.

## PART IV CRIMINAL APPEALS

Application of Part IV Cap. 4 s.8 **67.** This Part shall apply only to appeals and revisions from the High Court acting in original appellate and revisional jurisdiction in criminal cases and to matters relating to them.

Notice of appeal G.N. No. 344 of 2019 r.13 **68**.-(1) Any person who desires to appeal to the Court shall give notice in writing, which shall be lodged in triplicate with the Registrar of the High Court at the place where the decision against which it is desired to appeal was given, within thirty days of the date of that decision, and the notice of appeal shall institute the appeal.

(2) Every notice of appeal shall state briefly the nature of the acquittal, conviction, sentence, order or finding against which it is desired to appeal, and shall contain a full and sufficient address at which any notices or other documents connected with the appeal may be served on the appellant or his advocate and, subject to rule 17, shall be signed by the appellant or his advocate.

(3) Where two or more persons have been jointly tried and any two or more of them desire to appeal to the Court, they may at their option lodge separate notices or a joint notice of appeal, and where a joint notice of appeal is lodged, it may include, in addition to the grounds of appeal common to all the appellants, grounds peculiar to one or more of them.

(4) Where an appeal lies only on a certificate that a point of law is involved or with leave, it shall not be necessary to obtain that certificate or leave before lodging the notice of appeal.

(5) Where a notice of appeal is signed by or on behalf of an appellant who is in prison, it shall include a statement that the appellant intends or does not intend, as

the case may be, to appear at the hearing of his appeal.

(6) Where a notice of appeal is signed by an advocate, he shall add after his signature the words "Retained only to prepare this notice'; "Retained to appear at the hearing of the appeal' or "Assigned to appear at the hearing of the appeal", as the case may be.

(7) A notice of appeal shall be substantially in the Form B in the First Schedule to these Rules and shall be signed by or on behalf of the appellant.

(8) Notwithstanding the preceding provisions of this rule, where the notice of appeal deviates from the prescribed form, the Court may, on application by appellant or on its own motion, order its amendment.

**68A.** Where an appeal lies only on a certificate that a point of law is involved or with leave, and such certificate or a leave is denied, the notice of appeal shall be deemed to have been struck out and the Registrar shall make such entry in the register.

**69**.-(1) Where two or more appeals arising from the same trial are brought before the court, they shall, unless the Court orders otherwise be consolidated, and shall proceed as one appeal.

(2) Where two or more persons convicted by a subordinate court have appealed to the High Court where their appeals were consolidated and any two or more of them give notice of appeal to the Court, their appeals shall, unless the Court orders otherwise be consolidated and shall proceed as one appeal.

(3) In any other case, where the Court is of the opinion that it shall be convenient either for itself or for the parties concerned if two or more appeals were consolidated, it may, of its own motion or at the instance of any of the parties, direct that the appeals be consolidated and treated as one.

Transmission of notices of appeal

**70**. On receipt of a notice of appeal, the Registrar of the High Court shall forthwith send a copy each to the

Preparation of record of appeal

**71**.-(1)As soon as practicable after a notice of appeal has been lodged, the Registrar of the High Court shall prepare the record of appeal.

(2) For the purposes of an appeal from the High Court in its original jurisdiction, the record of appeal shall contain copies of the following documents in the following orders-

- (a) an index of all documents in the record with numbers of the pages at which they appear, showing also under the reference to the trial Judge's notes and under the reference to the transcript, if any, or shorthand notes, the names of the witnesses and the pages of the record at which their evidence appears;
- (b) the information, indictment or charge;
- (c) the proceedings on and after the sentence;
- (d) the record of the proceedings;
- (e) a list of all exhibits put in at the trial;
- (f) all documentary exhibits, photographs and plans put in at the trial and all depositions read in consequence of the absence of intended witnesses; but the Registrar of the High Court may in his discretion omit copies of documents which are of great length or other exhibits which are difficult to reproduce or may include copies of the relevant parts only of any of those documents;
- (g) the summing-up to the assessors, if there is a record of it, or of the Judge's notes on which he based his summing up and the opinions of the assessors;
- (h) the judgment;
- (i) the order, if any, giving leave to appeal or the certificate, if any, that there is a point of law involved; or
- (j) the notice of appeal.
  - 58

(3) Where any person convicted by a magistrate's court was committed for sentence to the High Court and is appealing to the Court against the sentence imposed by the High Court, the record of appeal shall, in addition to the documents specified in sub-rule (2), contain also a certificate by the Registrar of the High Court that -

- (a) the appellant was convicted on his own plea of guilty;
- (b) the appellant has lodged no notice of appeal against conviction and that the time for lodging the notice has expired; or
- (c) the appellant has appealed against conviction to the High Court and that the appeal has been determined, as the case may be.

(4) For the purposes of appeal from the High Court in its appellate jurisdiction, the record of appeal shall contain documents relating to the proceedings in the trial corresponding as nearly as may be to those set out in subrule (2) and shall contain also copies of the following documents relating to the appeal to the first appellate court

- (a) the petition of appeal;
- (b) the record of proceedings;
- (c) the judgment;
- (d) the order, if any,

and in the case of a third appeal, shall contain also the corresponding documents in relation to the second appeal and the certificate of the High Court that a point of law is involved.

(5) Notwithstanding the provisions of sub-rule (1), the Registrar of the High Court shall not prepare the record of appeal where -

- (a) the notice of appeal has been lodged out of time, until he has been notified that time has been extended by order of the High Court or of the Court unless the Chief Justice directs otherwise;
- (b) the appeal cannot be heard without leave to
  - 59

appeal or a certificate that a point of law is involved, until he has been notified that the leave or the certificate has been given or unless the Chief Justice directs otherwise;

(c) the appeal is from the High Court in its appellate jurisdiction, until the prescribed fee, or the part of it if any which the appellant may be liable to pay under an order under Rule 128, has been paid or a deposit in that behalf has been made to the satisfaction of the Registrar of the High Court.

(6) The Registrar of the High Court shall certify each copy of the record of appeal to be true copy of the original proceedings, save that where the record is produced by printing, type lithography, stencil duplicating, photography, or xerography, it shall suffice if one copy is so certified.

Memorandum of appeal

**72**.-(1)The appellant shall, within twenty one days after service on him of the record of appeal, lodge eight copies of the memorandum of appeal, with the Registrar or with the deputy registrar at the place where the appeal is to be heard.

(2) The memorandum of appeal shall set forth concisely and under distinct heads numbered consecutively, without argument or narrative, the grounds of objection to the decision appealed against specifying, in the case of a first appeal, the points of law or fact and, in the case of any other appeal, the points of law, which are alleged to have been wrongly decided.

(3) The Registrar or the deputy registrar, as the case may be, shall as soon as practicable cause a copy of the memorandum of appeal to be served on the respondent.

(4) A memorandum of appeal shall be substantially in the Form C in the First Schedule to these Rules and shall be signed by or on behalf of the appellant.

(5) Where no memorandum of appeal is lodged within the prescribed time, the Court may dismiss the appeal or may direct that it be set down for hearing, but

where an appeal is dismissed under this sub-rule, the appellant, if he shows sufficient cause may apply to the Court to restore it for hearing.

Supplementary memorandum

**73**.-(1) The appellant may, at any one time, with the leave of the Court, lodge a supplementary memorandum of appeal.

(2) An advocate who has been assigned by the Chief Justice or the presiding Justice to represent an appellant may, within twenty one days after the date when he is notified of his assignment, and without requiring the leave of the Court, lodge a memorandum of appeal on behalf of the appellant as supplementary to or in substitution for any memorandum which the appellant may have lodged.

(3) Any person lodging a supplementary memorandum under this rule shall cause a copy of the memorandum to be served on the respondent.

Presentation of arguments in writing 74.-(1)An appellant or, where the appellant is the State, a respondent who does not intend to appear in person or by advocate at the hearing of the appeal, may lodge with the Registrar or with the deputy registrar at the place where the appeal is to be heard a written statement of his arguments in support of or opposition to the appeal, as the case may be.

(2) Every such statement shall be signed by or on behalf of the appellant or respondent, as the case may be, and shall lodge eight copies at the time of or within twenty one days after lodging the memorandum of appeal.

(3) A person who has lodged a statement under this Rule shall be allowed to address the Court at the hearing of the appeal.

(4) On receipt of a statement under sub-rule (1), the Registrar or deputy registrar shall forthwith send one copy of it to the other party.

Where appellant is in prison **75**.-(1) Where the appellant is in prison, he shall be deemed to have complied with the requirements of rules 68, 72, 73 and 74 or any of them by filling Form B/1, Form



C/1 and handing over to the officer-in-charge of the prison in which he is serving sentence his intention to appeal and the particulars required to be included in the memorandum of appeal or statement, pursuant to the provisions of those rules.

(2) In any such case, in computing the time limited for lodging such notice, memorandum or statement, there shall be excluded-

- (a) the time between the appellant's conviction and his arrival at the prison to which he was committed; and
- (b) the time between the signing of the form, memorandum or statement to the officer-incharge of the prison and its lodging by him with the Registrar of the High Court or the Registrar or deputy registrar, as the case may be.

(3) An officer-in-charge of a prison receiving the form, memorandum of appeal or statement under this rule, shall forthwith endorse them with the date and time of receipt, and shall forward them to the Registrar of the High Court or the Registrar or deputy registrar, as the case may be.

(4) The provisions of this rule shall apply *mutatis mutandis* to applications.

Transmission of record etc., to Court

**76**.-(1) As soon as the record of appeal has been prepared, the Registrar of the High Court shall cause a copy of it to be served on the appellant and on the respondent and shall send four copies to the Registrar.

(2) The Registrar of the High Court shall at the same time send to the Registrar the original record of proceedings in the High Court, the original documentary exhibits in the High Court, other than any of great bulk, and a copy of the record of the preliminary inquiry, if any, but shall not send any exhibits other than documentary ones, unless requested to do so by the Registrar.

(3) The Registrar of the High Court shall ensure so far as practicable that all other exhibits are available for

inspection by the Court at the hearing of the appeal.

**77.**-(1) An appeal may be withdrawn at any time before hearing by a written notice to the Registrar signed by the appellant or his advocate, and upon that notice being given the appeal shall be deemed to have been dismissed.

(2) When any appeal is withdrawn, the Registrar shall forthwith notify the respondent and the Registrar of the High Court.

(3) An appeal which has been withdrawn may be restored by leave of the Court on the application of the appellant if the Court is satisfied that the notice of withdrawal was induced by fraud or mistake and that the interests of justice required that the appeal be heard.

(4) An appellant may, at any time in the course of hearing, informally apply to the Court for leave to withdraw the appeal and the Court may grant that application.

**78.**-(1)An appeal, other than an appeal against sentence of fine or an order for costs, compensation or forfeiture, shall abate on the death of the appellant or where the appellant is the State, on the death of the respondent.

(2) Upon the death of the appellant or the respondent, as the case may be, in an appeal against a sentence of fine or an order for costs, compensation or forfeiture, the Court shall, on the application of any interested person, cause the legal representative of the deceased to be made a party in the place of the deceased.

(3) Where an application under subrule (2) is not made within twelve months, the appeal shall, if the deceased person is the appellant, abate and if the deceased person is the respondent, proceed in the absence of the respondent.

(4) Any person claiming to be the legal representative of a deceased party or any other interested

Notice and time of hearing

**79.-**(1) The Registrar shall cause notice to be given to the appellant and to the respondent of the time and place at which an appeal will be heard.

(2) The notice shall be given not less than seven days before the date appointed for the hearing, unless in any case the Chief Justice or the presiding Justice directs otherwise.

**80**.-(1) The appellant and the respondent shall be entitled to be present at the hearing of the appeal.

(2) Where an appellant is represented by an advocate or has lodged a statement under rule 74 or is in prison it shall not be necessary for him to attend personally at the hearing of his appeal, unless the Court orders his attendance; but if an appellant is on bail he shall attend at the hearing of his appeal or with the leave of the Registrar, shall before the time of the hearing attend at the High Court at the place where the bail bond was executed and submit himself to the order of that court pending disposal of the appeal.

(3) Where an appellant is in prison and has stated that he does not intend to appear at the hearing of his appeal, the appeal shall be heard in his absence, unless the Court orders his attendance.

(4) Subject to the provisions of sub-rule (3), if on the day fixed for the hearing of an appeal the appellant does not appear in person or by advocate and has not lodged a statement under rule 74, the appeal may be dismissed or may be heard in his absence; save that where an appeal has been dismissed under this sub-rule, the Court may restore it for hearing if it is satisfied that the appellant was prevented by any sufficient cause from appearing when the appeal was called for hearing.

(5) The cost of transport to and from the Court of an appellant who is in prison and that of his escort shall be

borne out of the funds of the Treasury where-

- (a) the appellant who is under sentence of death is not represented by an advocate and desires to attend the hearing of his appeal; or

(6) If on the day fixed for the hearing of an appeal the respondent does not appear in person or by advocate, the appeal shall proceed, unless the Court sees fit to adjourn the hearing.

Arguments at hearing of appeal **81**.-(1) An appellant or his advocate, may be granted leave by the Court, to argue any ground of appeal not specified in the memorandum of appeal or in any supplementary memorandum lodged under rule 73.

(2) The arguments contained in any statement lodged under rule 74 shall receive the same consideration as if they had been advanced orally at the hearing.

# PART V APPEALS IN CIVIL MATTERS

Notice of appeal G.N. No. 344 of 2019 **83.**-(1) Any person who desires to appeal to the Court shall lodge a written notice in duplicate with the Registrar of the High Court.

(2) Every notice shall, subject to the provisions of rules 91 and 93, be so lodged within thirty days of the date of the decision against which it is desired to appeal.

(3) Every notice of appeal shall state whether it is intended to appeal against the whole or part only of the decision and where it is intended to appeal against part only of the decision, shall specify the part complained of, shall state the address for service of the appellant and shall state the names and addresses of all persons intended to be served with copies of the notice.

(4) When an appeal lies only with leave or on a certificate that a point of law is involved, it shall not be necessary to obtain the leave or the certificate before lodging the notice of appeal.

(5) Where it is intended to appeal against a judgment or decision of the High Court, it shall not be necessary for a copy of the judgment or decision to accompany the notice of appeal.

(6) A notice of appeal shall be substantially in the Form D in the First Schedule to these Rules and shall be signed by or on behalf of the appellant.

(7) Notwithstanding the preceding provisions of this rule, where the notice of appeal deviates from the prescribed form, the Court may, on application by appellant or on its own motion, order its amendment under rule 111 of these Rules.

Service of notice of appeal on person affected **84.**-(1) An intended appellant shall, before, or within fourteen days after lodging a notice of appeal, serve copies of it on all persons who seem to him to be directly affected by the appeal; but the Court may, on an *ex parte* application, direct that service need not be effected on any person who took no part in the proceedings in the High Court.

(2) Where any person required to be served with a copy of a notice of appeal gave any address for service in or in connection with the proceedings in the High Court, and has not subsequently given any other address for service, the copy of the notice of appeal may be served on

him at that address, notwithstanding that it may be that of an advocate who has not been retained for the purpose of an appeal.

Transmission of notice of appeal

**85**. On receipt of a notice of appeal lodged under the provisions of rule 83, the Registrar of the High Court shall forthwith send one copy of it to the appropriate registry.

Respondent to give address for service

**86**.-(1) Every person on whom a notice of appeal is served shall-

- (a) within fourteen days after service on him of the notice of appeal, lodge in the appropriate registry and serve on the intended appellant notice of a full and sufficient address for service; and
- (b) within a further fourteen days serve a copy of the notice of address for service on every other person named in the notice of appeal as a person intended to be served.

(2) The lodging service of an address for service shall not operate or be construed as an admission that the appeal is competent or as a waiver of any irregularity.

**86A.** The address for service referred to under rule 83(3) and 86 (1), shall contain the following particulars:

- (a) the name of appellant or respondent and the advocate, if any;
- (b) the description of the place of residence of the appellant or the respondent including the "kitongoji" or street name, email address, fax number, telephone number and post code if available; and
- (c) the description of the physical address of the office of the advocate, if any, including the street name, email address, fax number, telephone number and post code if available.

**87.** A notice of appeal shall not be incompetent by reason only that the person on whom it is required to be

Separate notices of appeal from same decision **88**.-(1) Where two or more parties have given notice of appeal from the same decision, the second and all subsequent notices to be lodged shall be deemed to be notices of address for service within the meaning of rule 86 and the party or parties giving those notices shall be respondents in the appeal.

(2) A party whose notice of appeal is deemed to be a notice of address for service shall not be required to comply with rule 86 if he has served copies of his notice of appeal on all persons on whom under that rule he would have been required to serve a notice of his address for service.

Application to withdraw notice of appeal and to strike out notice of appeal or appeal G.N. No. 344 of 2019 r.18 Cap. 4 s.8 **89**.-(1) An application to withdraw a notice of intention to appeal may be made any time before instituting the appeal and a copy of the notice shall be served upon all parties on whom the notice was served.

(2) Subject to the provisions of subrule (1), any other person on whom a notice of appeal was served or ought to have been served may at any time, either before or after the institution of the appeal, apply to the Court to strike out the notice of appeal or the appeal, as the case may be, on the ground that no appeal lies or that some essential step in the proceedings has not been taken or has not been taken within the prescribed time.

(3) Where the Court strikes out a notice of appeal under sub rule (2) after an appeal has been lodged, the appeal shall be deemed to have been struck out and the Registrar shall mark it accordingly.

Institution of appeals G.N. No. 362 of 2017 r.13 344 of 2019 **90**.-(1) Subject to the provisions of rule 128, an appeal shall be instituted by lodging in the appropriate registry, within sixty days of the date when the notice of appeal was lodged with -

(a) a memorandum of appeal in quintuplicate;

- (b) the record of appeal in quintuplicate;
- (c) security for the costs of the appeal,

save that where an application for a copy of the proceedings in the High Court has been made within thirty days of the date of the decision against which it is desired to appeal, there shall, in computing the time within which the appeal is to be instituted be excluded such time as may be certified by the Registrar of the High Court as having been required for the preparation and delivery of that copy to the appellant.

(2) The certificate of delay under rules 45, 45A and 90(1) shall be substantially in the Form L as specified in the First Schedule to these Rules and shall apply *mutatis mutandis*.

(3) An appellant shall not be entitled to rely on the exception to sub-rule (1) unless his application for the copy was in writing and a copy of it was served on the Respondent.

(4) The period limited by sub-rule (1) for the institution of appeals shall apply to appeals in the exercise of its bankruptcy jurisdiction.

(5) Subject to the provisions of subrule (1), the Registrar shall ensure a copy of the proceedings is ready for delivery within ninety (90) days from the date the appellant requested for such copy and the appellant shall take steps to collect copy upon being informed by the Registrar to do so, or within fourteen (14) days after the expiry of the ninety (90) days.

Effect of default in instituting appeal

**91**. Where a party who has lodged a notice of appeal fails to institute an appeal within the appointed time

- (a) he shall be deemed to have withdrawn his notice of appeal and shall, unless the Court orders otherwise, be liable to pay the costs of any persons on whom the notice of appeal was served arising from that failure to institute the appeal;
- (b) any person on whom the notice of appeal

was served shall be entitled to give notice of appeal notwithstanding that the appointed time has expired, if he does so within fourteen days of the date by which the party who lodged the previous notice of appeal should have instituted his appeal.

Death of party to intended appeal **92.** (1) An appeal shall not be instituted in the name of a person who is dead but may be instituted in the name of his legal representative.

(2) An appeal shall not be incompetent by reason only that the respondent was dead at the time when it was instituted but the Court shall on the application of any interested person cause the legal representative of the deceased to be made a party in place of the deceased.

Memorandum of appeal

**93.**-(1) A memorandum of appeal shall set forth concisely and under distinct heads, without argument or narrative, the grounds of objection to the decision appealed against, specifying the points which are alleged to have been wrongly decided, and the nature of the order which it is proposed to ask the Court to make.

(2) The grounds of objection shall be numbered consecutively.

(3) A memorandum of appeal shall be substantially in the Form F in the First Schedule to these Rules and signed by or on behalf of the appellant.

Notice of crossappeal **94**.-(1) A respondent who desires to contend at the hearing of the appeal that the decision of the High Court or any part of it shall be varied or reversed, either in any event or in the event of the appeal being allowed in whole or in part, shall give notice to that effect, specifying the grounds of his contention and the nature of the order which he proposes to ask the Court to make or to make in that event, as the case may be.

(2) A notice given by a respondent under this rule shall state the names and addresses of any persons intended to be served with copies of the notice and shall be

lodged in quadruplicate in the appropriate registry not more than thirty days after service on the respondent of the memorandum of appeal and the record of appeal.

(3) A notice of cross-appeal shall be substantially in the Form G in the First Schedule to these Rules and shall be signed by or on behalf of the respondent.

**95.**-(1) For the purposes of an appeal to the Court against any decree or order, it shall not be necessary for the amount of any costs ordered to be paid to be stated in it, and such decree or order shall be deemed to be duly drawn up and extracted if, in addition to other matters required to be embodied in it, it sets out the order or orders for costs but not the result of any taxation.

(2) Where leave to appeal or for a certificate that a point of law is involved has been given or refused by the High Court immediately following the delivery of the decision against which it is desired to appeal, a statement that leave or a certificate has been given or refused shall be included in the decree or order.

**96.**-(1) For the purposes of an appeal from the High Court or a tribunal, in its original jurisdiction, the record of appeal shall, subject to the provisions of sub-rule (3), contain copies of the following documents-

- (a) an index of all the documents in the record with the numbers of the pages at which they appear;
- (b) a statement showing the address for service of the appellant and the address for service furnished by the respondent and, as regards any respondent who has not furnished an address for service as required by rule 86, his last known address and proof of service on him of the notice of appeal;
- (c) the pleadings;
- (d) the record of proceedings;
- (e) the transcript of any shorthand notes taken at the trial;

- (f) the affidavits read and all documents put in evidence at the hearing, or, if such documents are not in the English language, their certified translations;
- (g) the judgment or ruling;

- (k) such other documents, if any, as may be necessary for the proper determination of the appeal, including any interlocutory proceedings which may be directly relevant,

save that the copies referred to in paragraphs (d), (e) and (f) shall exclude copies of any documents or any of their parts that are not relevant to the matters in controversy on the appeal.

(2) For the purposes of any appeal from the High Court in its appellate jurisdiction, the record of appeal shall contain documents relating to the proceedings in the trial court corresponding as nearly as may be to those set out in sub-rule (1) and shall contain also the following documents relating to the appeal to the first appellate court-

- (a) the order if any giving leave to appeal;
- (b) the memorandum of appeal;
- (c) the record of proceedings;
- (d) the judgment or ruling;
- (e) the decree or order;
- (f) the notice of appeal,

and in the case of a third appeal, shall contain also the corresponding documents in relation to the second appeal and the certificate of the High Court that a point of law is involved.

(3) A Justice or Registrar of the High Court or tribunal, may, on the application of any party, direct which documents or parts of documents should be excluded from the record, application for which direction may be made informally.

- (4) The documents mentioned in sub-rule (1) shall

be bound in the order in which they are specified in that sub-rule and documents produced in evidence; shall be put in order of the dates they bear or, where they are undated, the dates when they are believed to have been made, without regard to the order in which they were produced in evidence but an affidavit filed in support of a chamber summons or notice of motion shall be bound immediately following the summons or notice, as the case may be.

(5) Each copy of the record of appeal shall be certified to be correct by the appellant or by any person entitled under rule 33 to appear on his behalf.

(6) Where a document referred to in rule 96(1) and (2) is omitted from the record of appeal the appellant may within fourteen days of lodging the record of appeal, without prior permission and thereafter, informally, with the permission of the Registrar, include the document in the record of appeal by lodging an additional record of appeal.

(7) Where the case is called on for hearing, the Court is of opinion that document referred to in rule 96(1) and (2) is omitted from the record of appeal, it may on its own motion or upon an informal application grant leave to the appellant to lodge a supplementary record of appeal.

(8) Where leave to file a supplementary record under subrule (7), has been granted, the Court shall not entertain any similar application on the same matter.

**97**.-(1) The appellant shall, before or within seven days after lodging the memorandum of appeal and the record of appeal in the appropriate registry, serve copies of them on each respondent who has complied with the requirements of rule 86.

(2) The appellant shall also serve copies of the memorandum of appeal and the record of appeal on such other parties to the original proceedings as the Court may at any time on application or of its own motion direct and within such time as the Court may appoint.

(3) A notice of grounds for affirming a decision shall be substantially in the Form H in the First Schedule to these Rules and shall be signed by or on behalf of the respondent.

(4) A respondent who desires to contend at the hearing of the appeal that part of the decision of the High Court should be varied or reversed and that part of that decision should be affirmed on grounds other than or additional to those relied upon by that court may include both contentions in a notice of cross-appeal under rule 94 and shall not be required to give notice also under this rule.

(5) The provisions of sub-rules (1), (2) and (3) of this rule and those of Rule 101 shall apply *mutatis mutandis* to an appellant who desires to contend in opposition to a cross-appeal that the decision of the High Court should be affirmed on grounds other than or additional to those relied on by that court.

Service of notice of crossappeal or of grounds for affirming decision **101**.-(1) A respondent who intends to cross-appeal or to contend that the decision of the High Court should be affirmed on grounds other than those relied on by that court shall, before or within seven days after lodging his notice of cross-appeal or notice of grounds for affirming the decision, as the case may be, serve a copy of it on the appellant and copies of it on all other persons directly affected by the cross-appeal or by the appeal, as the case

may be.

(2) The respondent shall also serve copies of the notice of cross-appeal or notice of grounds for affirming the decision, as the case may be, on such other parties to the original proceedings as the Court may at any time on application or of its own motion direct and within such time as the Court may appoint.

Withdrawal of appeal G.N. No. 362 of 2017 r.14. **102**.-(1) An appellant may at any time in the course of hearing, informally apply to the Court for leave to withdraw the appeal and the Court may grant the application upon such terms as to costs or other conditions as it deems fit.

(2) Notwithstanding sub-rule (1), an appellant may at any time after instituting his appeal and before the appeal is called on for hearing lodge in the appropriate registry a written notice that he does not intend further to prosecute the appeal and upon receiving such notice the Registrar shall mark the appeal withdrawn.

(5) Where all the parties to the appeal do not consent to the withdrawal of the appeal, the appeal shall stand dismissed with costs, except as against any party who has consented, unless the court, on the application of the appellant, otherwise orders.

(6) An application under sub-rule (5) shall be made within fourteen days after the lodging of the notice of withdrawal.

**105**.-(1) An appeal shall not abate on the death of the appellant or the respondent but the Court shall, on the application of any interested person, cause the legal representative of the deceased to be made a party in place of the deceased.

(2) Where an application under subrule (1) is not made within twelve (12) months, the appeal shall, if the deceased person is the appellant, abate and if the deceased person is the respondent, proceed in the absence of the respondent.

Presentation of written submissions G.N. Nos. 362 of 2017 **106**.-(1) An appellant or applicant shall, within sixty days after lodging the record of appeal or filing the notice of motion, file in the appropriate registry written submissions in support of the appeal or application as the case may be.

(2) Where the appellant or applicant fails to file the written submissions within the time prescribed subrule (1), the respondent may, without prejudice to sub rule (7), file written submissions in opposition to the appeal or application within fifteen (15) days thereafter.

- (3) The written submissions shall contain –
- (a) a concise statement of the case containing the facts material to the appeal, cross appeal or application;
- (b) statement of what are, in the appellant's or applicant's view, the issues arising in the appeal, cross appeal or application-

(4) Where the parties intend to invite the Court to depart from one of its own decisions, this shall be clearly stated in a separate paragraph of the submissions, to which special attention shall be drawn, and the intention shall also be restated as one of the reasons.

(5) An appellant or applicant who has lodged written submissions under subrule (1) may, if served with notice of a cross-appeal, lodge supplementary submissions of his arguments in opposition to it within fourteen (14) days of service.

(6) A copy of the written submissions shall be served upon the opposite party within fourteen (14) days from the date of filing.

(7) A respondent shall file a copy of a reply to the submissions of the appellant or applicant not later than thirty (30) days from the date of service by the appellant or applicant upon him.

(8) A copy of the respondent's written submissions shall be served upon the appellant or applicant within fourteen (14) days from the date of filing.

(9) Upon expiry of the time for filing written submissions, the Registrar shall fix a date of hearing and notify the parties or their advocates.

(10) At the hearing, the parties or their advocates shall appear and, where-

- (a) written submissions have been filed, present oral arguments to clarify their written submissions; or
- (b) no written submissions have been filed, present

oral arguments in support of or in opposition to the appeal, cross appeal or application as the case may be.

(11) For purposes of subrule (10) no party shall be allowed to present oral arguments for more than half an hour unless the Court, on its own motion or upon application by either party, directs otherwise:

Provided that, failure to file written submissions or a reply shall not be a ground for applying for additional time for oral submissions under the provisions of this rule.

(12) Where an appeal or application is called on for hearing and written submissions have been duly filed and-

- (a) neither party nor their advocates appear to present oral arguments; or
- (b) either party or his advocate appears to present oral arguments, the appeal, shall be treated as having been argued and shall be considered as such:

Provided that a party or his advocate who appears, shall be afforded an opportunity to present oral argument.

(13) Notwithstanding the provisions of this rule, the Court may, where it considers the circumstances of an appeal, cross appeal or application to be exceptional, or that the hearing of an appeal must be accelerated in the interest of justice, waive compliance with the provisions of this rule in so far as they relate to the preparation and filing of written submissions, either wholly or in part, or reduce the time limits specified in this rule, to such extent as the Court may deem reasonable in the circumstances of the case.

Preliminary objection G.N. No. 362 of 2017 r.16 Cap.4 s.8 **107**.-(1) A respondent intending to rely upon a preliminary objection to the hearing of the appeal or application shall give the appellant or applicant three clear days notice thereof before hearing, setting out the grounds of objection such as the specific law, principle or decision relied upon, and shall file five such copies of the notice with the Registrar within the same time and copies of the law or decision, as the case may be, shall be attached to the

notice.

(2) A respondent shall not rely upon a preliminary objection unless such objection consists of a point of law which, if argued and sustained, may dispose of the appeal or application.

(3) A respondent raising a preliminary objection shall provide such necessary particulars to enable the Court and the other party to grasp the nature and scope of such objection.

**108.** The Registrar shall give all parties to an appeal not less than fourteen days' notice of the date fixed for the hearing of the appeal; but it shall not be necessary to give that notice to any party with whose consent the date for the hearing was fixed.

No. 344 of 2019 r.23 **112.**-(1) Where on any day fixed for the hearing of an appeal, the appellant does not appear, the appeal may be dismissed and any cross-appeal may proceed, unless the Court sees fit to adjourn the hearing, save that where an appeal has been so dismissed or any cross-appeal so allowed has been heard, the appellant may apply to the Court to restore the appeal for hearing or to re-hear the cross-appeal:

Provided that the appellant shows that he was prevented by any sufficient cause from appearing when the appeal was called on for hearing.

(2) Where the appellant appears and the respondent fails to appear, the appeal shall proceed in the absence of the respondent and any cross-appeal may be dismissed, unless the Court sees fit to adjourn the hearing; but where an appeal has been allowed or a cross-appeal dismissed in the absence of the respondent, he may apply to the Court to re-hear the appeal or to restore the cross-appeal for hearing, if he can show that he was prevented by any sufficient cause from appearing when the appeal was called on for hearing.

(3) An application for restoration under the proviso to sub-rule (1) or the proviso to sub-rule (2) shall be made within thirty days of the decision of the Court, or in the case of a party who should have been served with a notice of the hearing but was not served, within thirty days of his first hearing of that decision.

(4) For the purposes of this rule, a party who has lodged written submissions under the provisions of rule 106 shall be deemed to have appeared.

Arguments at hearing of appeal Cap.4 s.8 **113**.-(1) A party shall not without the leave of the Court, argue that the decision of the High Court or tribunal, should be reversed or varied except on a ground specified in the memorandum of appeal or in a notice of cross-appeal, or in support of the decision of the High

Court or tribunal on any ground not relied on by that court or specified in a notice given under rule 94 or rule 100.

(2) A party shall not without the leave of the Court, raise any objection to the competence of the appeal which might have been raised by application under Rule 89.

(3) The Court shall not allow an appeal or crossappeal on any ground not specified or implicit in the memorandum of appeal or notice of cross-appeal, without affording the respondent, or any person who in relation to that ground should have been made a respondent or the appellant, as the case may be, an opportunity of being heard on that ground.

(4) At the hearing of an appeal, the arguments contained in any statement lodged under rule 106 shall receive the same consideration as if they had been advanced orally at the hearing.

Orders as to costs

**114.**-(1) The Court may make such order as to the whole or any part of the costs of appeal in the court below as may be just, and may assess them or direct taxation of them; and in the case of a second appeal this rule shall apply to costs in the trial court as well as in the first appellate court.

(2) Where more than one advocate have appeared in a matter, the Court shall direct the number of advocates entitled to costs.

Immaterial errors in civil matters G.N. No. 344 of 2019 r.24 115. No judgment, decree or order of the High Court shall be revised or substantially varied on appeal, nor a new trial ordered by the Court, on account of any error, defect or irregularity, whether in the decision or otherwise, not affecting the merits, or the jurisdiction of the High Court; and in the case of a second or third appeal, this rule shall be construed as applying to the trial court, the first and second appellate courts, as the case may be.

Judgment

**116**.-(1) The judgment of the Court shall be pronounced in open court, either on the hearing or not later than ninety days from the date of hearing unless the court

directs otherwise.

(2) Where the judgment cannot be delivered within the 90 days prescribed in sub rule (1), the Court shall inform the parties on the next available date for delivery of judgment.

(3) Such judgment may be pronounced notwithstanding the absence of the Judges who composed the Court or any of them, and the judgment of any Justice not present may be read by a Justice or by the Registrar.

(4) A certified copy of the judgment shall be sent by the Registrar to the High Court.

**117**.-(1) Except as hereinafter provided, the Court may order that a new trial be held of any matter tried by the High Court in the exercise of its original jurisdiction.

(2) A new trial shall not be granted on the ground of the improper admission or rejection of evidence unless in the opinion of the Court some substantial wrong or miscarriage of justice has thereby been occasioned; and if it appears to the Court that such wrong or miscarriage affects part only of the matters in controversy, or some or one only of the parties, the Court may give final judgment as to part of the matters, or as to some or one only of the parties, and direct a new trial as to the other part only, or as to the other party or parties.

(3) A new trial may be ordered on any question without interfering with the finding or decision upon any other question.

(4) In the case of a second appeal this rule shall extend to empower the Court to order a retrial by the trial court or a re-hearing of the first appeal by the first appellate court.

**119**.-(1) The fees payable on lodging any document shall be payable at the time when the document is lodged.

(2) The Registrar or Registrar of the High Court may require the payment in advance of the fee for any other service or, where the amount of the fee cannot conveniently be ascertained when the service is requested, may require a deposit towards it.

(3) Subject to subrule (2) any fee so paid in advance or deposit made shall be refunded if the request for the service is cancelled before the service has been undertaken.

appeal as security for the costs of the appeal the sum of two thousand shillings.

(2) Where an appeal has been withdrawn under rule 102 after notice of cross-appeal has been given, the Court may, on the application of any person who is a respondent to the cross-appeal, direct the cross-appellant to lodge in Court as security for costs the sum of two thousand shillings or any specified sum less than two thousand shillings, or may direct that the cross-appeal be heard without security for costs being lodged.

(3) The Court may, at any time if it thinks fit, direct that further security for costs be given and may direct that security be given for the payment of past costs relating to the matters in question in the appeal.

(4) Where security for costs has been lodged the Registrar may pay it out either by consent of the parties or in conformity with the decision of the Court having regard to the rights of the parties under that decision.

Assessment or taxation of costs

**121.**-(1) Subject to rule 114, when making any decision as to the payment of costs, the Court may assess them or direct them to be taxed, and any decision as to the payment of costs, not being a decision whereby the amount of the costs is assessed, shall operate as a direction that the costs be taxed.

(2) For the purposes of execution in respect of costs, the decision of the Court directing taxation and the certificate of the taxing officer as to the result of such taxation shall together be deemed to be a decree.

Costs improperly incurred **122.** Where it appears to the Court that costs have been incurred improperly or without reasonable cause, or that by reason of any undue delay in proceeding under any judgment or order, or of any misconduct or default of the advocate, any costs properly incurred have nevertheless proved fruitless to the person incurring them, the Court may call on the advocate by whom such costs have been so incurred to show cause why those costs should not be

borne by the advocate personally, and thereupon may make such order as the justice of the case may require.

(2) Any person who contends that a bill of costs as taxed is, in all the circumstances, manifestly excessive or manifestly inadequate, may require the bill to be referred to a Justice and the Justice shall have power to make such deduction or addition as will render the bill reasonable; and save as is provided by this sub-rule, there shall be no reference on a question of quantum only.

(3) An application for reference may be made to the Registrar informally at the time of taxation or by writing within seven days after taxation.

(4) A reference to a Justice may be adjourned by

him for the consideration of the Court.

(5) Any person dissatisfied with a decision of a Justice given under sub-rule (1) or sub-rule (2) may apply to the Court to vary, discharge or reverse the decision.

(6) The application may be made either informally to the Justice at the time of the decision or by writing to the Registrar within seven days of that time.

Waiver of fees in criminal appeals **126**.-(1) Where in any appeal from the High Court acting in appellate jurisdiction in any criminal matter, a judge of the High Court is satisfied on the application of the appellant

- (a) that the appeal raises one or more questions of law proper for determination by the Court; and
- (b) that the appellant ought not, by reason of poverty, to be required to pay the whole of the fees ordinarily payable, including fees for preparing the record of appeal, he may by order direct that the whole or any part of the fees be waived.

(2) An application for an order under sub-rule (1) may be made informally at any time but not later than seven days after the appellant has been informed of the amount which, in the absence of an order, he would be required to pay as fees or to deposit in respect of fees; save that a judge of the High Court may entertain any such application out of time if it appears to him that there was sufficient cause for the delay in making it.

(3) No fee shall be payable on the lodging of any such application.

(4) A Judge of the High Court considering the means of an applicant may rely on a report made to him by the Registrar of the High Court.

(5) A Judge of the High Court making an order under sub-rule (1) may, at the same time and without formal application, order the extension of the time for giving notice of appeal or for lodging the memorandum of appeal.

(6) An order allowing or dismissing an application under sub-rule (1) shall be final; but the decision by the Judge of the High Court that an appeal raises or does not raise a question of law proper for determination by the Court shall be conclusive of that question only in relation to the application.

**127.** Where an appeal is allowed from the High Court in its appellate jurisdiction, the Court may for sufficient reason order the refund to the appellant of the fees or any part of them paid by him under these Rules.

- (a) without prior payment of fees of Court, or on payment of any specified amount less than the required fees;

and may order that the record of appeal be prepared by the Registrar of the High Court without payment for it or on payment of any specified sum less than the fee specified in the Second Schedule, conditionally on the intended appellant undertaking to pay the fees or the balance of the fees out of any money or property he may recover in or in consequence of the appeal.

(2) The Registrar shall be entitled to be heard on any such application.

# PART VII MISCELLANEOUS PROVISIONS

Revocation G.N. No. 103 of 1979 **129.** The Court of Appeal Rules are hereby revoked.

130. In all proceedings pending whether in the Court or High Court, preparatory or incidental to, or consequential upon any proceeding in court the provisions of these rules shall apply, but without prejudice to the validity of anything previously done;

- (a) if and so far as it is impracticable in any such proceedings to apply the provisions of these rules, the practice and procedure heretofore obtaining shall be followed; or
- (b) in any case of difficulty or doubt the Chief Justice may issue practice notes or directions as to the procedure to be adopted.

# THIRD SCHEDULE

# TAXATION OF COSTS

### (Made under rule 124)

### 1. Interpretation

In this Schedule, a folio means one hundred words, and a single figure or a group of figures up to seven shall count as one word.

## 2. Lodging and service of bill of costs

- (1) Where costs are to be taxed, the advocate for the party to whom the costs were awarded shall lodge his bill with the taxing officer and shall, before or within seven days after lodging it, serve a copy of it on the advocate for the party liable to pay it.
- (2) A bill of costs shall be lodged as soon as practicable after the making of the order for costs or not later than twenty-one days after a request in writing therefore by the party liable, or such further time as the Registrar may allow.
- (3) A bill of costs may not be lodged by an advocate who is not on the record.

### 3. Form of bill

- (1) A bill of costs shall be instituted and filed in the proceedings and shall be in the form of a bill prepared in five columns as follows
- (a) the first of left hand column for the dates of the items;
  - (b) the second column for the serial numbers of the items;
  - (c) the third column for the particulars of the service charged for;
  - (d) the fourth column for the professional remuneration or scale charged;
  - (e) the fifth column for the taxing officer's deductions.
- (2) Every bill of costs shall be endorsed with

- (a) the name and address of the advocate lodging the same;
- (b) the name and address of every party to be served or his advocate;
- (c) a certificate signed by the advocate lodging the bill that the number of folios, in respect of any item in the bill charged for by the folio, is correct; and if such certificate is found to be incorrect the item may be disallowed.
- (3) Every bill of costs shall be endorsed at the end thereof with a form of certificate for signature by the taxing officer certifying the result of the taxation.

### 4. **Disbursements**

- (1) Disbursements shall be shown separately at the foot of the bill of costs.
- (2) Receipts for all disbursements shall be produced to the taxing officer at the time of taxation.
- (3) No disbursement shall be allowed which has not been paid at the time of taxation.

### 5. **Bills not to be altered after lodging**

No alteration or addition to a bill of costs once lodged shall be made except by consent of the parties

or by permission of the taxing officer or a Judge.

### 6. **Notice of taxation**

When a bill of costs has been lodged as aforesaid, the taxing officer shall issue a notice to all parties concerned or their advocates giving the date, time and place at which the bill will be taxed.

## 7. **Time and adjournment**

The taxing officer shall have power to limit or extend the time for any proceeding before him, and to adjourn the same from time to time and from place to place.

### 8. **Failure to attend taxation**

If any party or advocate who has been duly served with a notice of taxation fails to appear at the date and time specified in such notice, the taxing officer may proceed to tax the bill notwithstanding such absence.

## 9. **Quantum of costs**

- (1) The fee to be allowed for instructions to make, support or oppose any application shall be such sum as the taxing officer shall consider reasonable but shall not be less than Shs. 100/-.
- (2) The fee to be allowed for instructions to appeal or to oppose an appeal shall be such sum as the taxing officer shall consider reasonable, having regard to the amount involved in the appeal, its nature, importance and difficulty, the interest of the parties, the other costs to be allowed, the general conduct of the proceedings, the fund or person to bear the costs and all other relevant circumstances.
- (3) The sum allowed under subparagraph (2) shall include all work necessarily and properly done in connection with the appeal and not otherwise changeable including attendances, correspondence, perusals and consulting authorities
- (4) Other costs shall, subject to the provisions of paragraphs 10, 11 and 12, be awarded in accordance with the scale set out in this schedule or, in respect of any matter for which no provision is made in those scales, in accordance with the scale applicable in the High Court.

### 10. Fees for drawing documents

The fee for drawing a document shall include the preparation of all copies for the use of the party drawing it and for filing and service when only one other party or one advocate for other parties has to be served; where there are additional parties, fees may be charged for making the necessary additional copies.

### 11. **Taxation of bills**

- (1) On taxation, the taxing officer shall allow such costs, charges and disbursements as shall appear to him to have been reasonably incurred for the attainment of justice but no costs shall be allowed which appear to the taxing officer to have been incurred through overpayment, extravagance, over caution, negligence or mistake or by payment of special charges or expenses to witnesses or other persons or by other unusual expenses.
- (2) In taxing the costs of any civil appeal, the taxing officer shall disallow the costs of any matter improperly included in the record of appeal or in any supplementary record of appeal.

## 12. **Overriding discretion**

If, after a bill of costs has been taxed, the taxing officer considers that, having regard to all the circumstances, the total of the bill before signing the certificate of taxation is excessive, he may make such a deduction from the total as will in his opinion render the sum reasonable.

## 13. Excessive claims

If more than one quarter of the profit costs claimed is disallowed on taxation the costs of drawing, filing and serving the bill and of attending taxation shall be disallowed.

## 14. **Set-off of costs**

Where a party entitled to receive costs is also liable to pay costs, the taxing officer may tax the costs which that party is liable to pay and adjust them by way of deduction or set-off and direct payment of any balance.

## 15. **Costs of more than one advocate**

(1) Costs of more than one advocate shall not be allowed unless the Court has so directed:

Provided that if an advocate has instructed another advocate to appear at the hearing of an appeal, the fee paid to the latter, or so much thereof as the taxing officer considers reasonable, may be allowed but so that the total of such fee and the instructions fee allowed to the instructing advocate shall not be greater than it would have been if one advocate only had acted in the matter.

- (2) Where the Court has directed that the costs of two advocates be allowed
  - (a) where the senior advocate is not a member of the same firm as the advocate on the record, he shall be allowed the fee paid to him, including fees for attending in court, or so much thereof as the taxing officer shall consider reasonable;
  - (b) where the senior advocate is a member of the same firm as the advocate on the record, he shall be allowed such fee as would have been allowed in the case of an advocate not a member of that firm; and
  - (c) the advocate on the record shall be allowed the usual instruction, hearing and other fees.
- (3) The fee paid to another advocate by the advocate on the record shall be shown as a disbursement.

## 16. Costs where advocate changed during proceedings

If there has been a change of advocates the bill of costs of the first advocate may be annexed to that of the correct advocate and its total shown as a disbursement. The bill will be taxed in the ordinary way, the current advocate being heard on it, but the taxing officer may require the first advocate to attend.

### 17. **Two or more parties**

Where the same advocate is employed for two or more parties and separate proceedings are taken by or on behalf of any two such parties, the taxing officer shall consider in the taxation of such advocate's bill of costs whether such separate proceeding were necessary and proper, and if he is of opinion that any part of the costs occasioned thereby has been unnecessarily or improperly incurred, the same shall be disallowed.

### 18. **Costs where trustees defend separately**

In taxing the costs as between party and party or for payment out of a trust fund of joint executors or trustees who are separately represented, the taxing officer shall, unless otherwise ordered by the Court or a Judge, allow only one set of costs for such parties, such costs to be apportioned among them as the taxing officer shall deem fit.

### 19. Expenses of persons attending hearing

The taxing officer shall allow the reasonable expenses of a party who appeared in person at the hearing of an application or appeal and those of a witness who gave evidence at any such hearing but shall not allow the expenses of any person who may have attended the hearing, unless the Court has so ordered.
