In exercise of the powers vested in me by Article 7 of the Tanganyika Orders in Council, 1920 to 1961, I, JOHN FLETCHER-COOKE, Companion of the Most Distinguished Order of Saint Michael and Saint George, Acting Governor and Commander-in-Chief of Tanganyika, do hereby proclaim and notify as follows:—

The Schedule to the Establishment of Provinces and Extra-Provincial Districts Proclamation, 1959, is hereby amended with effect from the first day of July, 1961, by deleting the words "The Moshi District" occurring in the second column thereof and substituting therefor the words "The Kilimanjaro District".
