THE EAST AFRICAN INCOME TAX (MANAGEMENT)

ACT, 1958

(No. 10 OF 1958)

ORDER

In exercise of the powers conferred by subsection (2) of section 13 of the East African Income Tax (Management) Act, 1958, the President of the United Republic of Tanzania, hereby makes the following Order:—

THE EAST AFRICAN INCOME TAX (EXEMPTION) (TANZANIA) ORDER, 1965

1. This Order may be cited as the East African Income Tax (Exemption) (Tanzania) Order, 1965.
2. The income payable to persons not resident in East Africa on—
 - (a) the Tanganyika 6½ per cent stock 1975/78 shall be exempt from tax as from the first day of July, 1963; and
 - (b) the United Republic of Tanzania 6¾ per cent stock, 1970/71 shall be exempt from tax, as from the second day of November, 1964.
