THE AIRPORT SERVICE CHARGE ACT, 1962
 (ACT 26 OF 1962)

ORDER

Made under section 5 (1)

THE AIRPORT SERVICE CHARGE (EXEMPTION) ORDER, 1962

1. This Order may be cited as the Airport Service Charge (Exemption) Order, 1962.

2.—(1) A passenger on an internal ticket which is replaced by another internal ticket solely in order to enable the passenger to break his journey at a place or places between the first place of embarkation and the last place of disembarkation of the journey for which such first

ticket and if no further sum is payable by the passenger for such further ticket, shall, on production of the receipt for the payment of the charge on the occasion of his first embarking at an airport on the journey for which such first-mentioned ticket is valid, be exempt from the charge on any occasion on which he embarks for a further journey for which such replacement ticket is valid.

(2) In this Order, the expression "internal ticket" has the meaning ascribed to it in subsection (6) of section 4 of the Airport Service Charge Act, 1962.
