NOW, THEREFORE, I, ISAAC MULLER BHOKE MUNANKA, Minister of State (Regional Administration), in exercise of the powers conferred upon me by sub-section (1) of section 10 of the Ordinance, after consultation with the Mtwara-Mikindani Town Council, do hereby make the following Amending Instrument: —

1. This Instrument may be cited as the Local Government (Mtwara-Mikindani Town Council) Amending Instrument, 1965 and shall be read as one with the Local Government (Mtwara-Mikindani Town Council) Instrument, 1962, as amended from time to time (hereinafter referred to as the principal Instrument).

2. Clause 7 of the principal Instrument is hereby amended by deleting therefrom the words and commas "the District Engineer, Mtwara," and substituting therefor the following: —

3. Clause 11 of the principal Instrument is hereby amended by inserting immediately after the number, brackets and comma "(129)," in the eighth line of sub-clause (x) thereof the number, brackets and comma "(129A),".

AMENDING INSTRUMENT

AMENDING THE INSTRUMENT ESTABLISHING THE
MUSOMA TOWN COUNCIL

Under section 10 (1)

THE LOCAL GOVERNMENT (MUSOMA TOWN COUNCIL) AMENDING
INSTRUMENT, 1965

WHEREAS the Minister for Local Government and Administration in exercise of the powers conferred upon him by section 4 of the Local Government Ordinance (hereinafter called the Ordinance) and with the prior approval of the National Assembly signified by resolution, on the thirtieth day of November, 1962, made an Instrument establishing the Musoma Town Council, called the Local Government (Musoma Town Council) Instrument, 1962:

AND WHEREAS it is considered desirable to amend the Local Government (Musoma Town Council) Instrument in the manner hereinafter appearing:

NOW, THEREFORE, I, ISAAC MULLER BHOKE MUNANKA, Minister of State (Regional Administration), in exercise of the powers conferred upon me by sub-clause (1) of section 10 of the Ordinance, after consultation with the Musoma Town Council, do hereby make the following Amending Instrument: —

1. This Instrument may be cited as the Local Government (Musoma Town Council) Amending Instrument, 1965 and shall be read as one with the Local Government (Musoma Town Council) Instrument, 1962, as amended from time to time (hereinafter referred to as the principal Instrument).

2. Clause 11 of the principal Instrument is hereby amended as follows: —

- (a) by deleting sub-clause (iv) thereof and substituting therefor the following new sub-clause to be numbered (iv): — “(iv) shall maintain and supervise any highway which the Council is under a duty to maintain and supervise under the provisions of the Highways Ordinance, and all drains, ditches, embankments and bridges belonging or appertaining thereto”;
- (b) by deleting sub-clause (v) thereof and substituting therefor the following new sub-clause to be numbered (v): —“(v) may maintain, supervise, or grant sums of money towards the maintenance or supervision of any road, street, footpath, bridge, square, sewer, drain or culvert which has usually been maintained in whole or in part out of public funds prior to the date hereof”;
- (c) by inserting immediately after the word and comma “streets,” in the first line of sub-clause (vi) thereof the word and comma “footpaths”; and
- (d) by inserting immediately after the number, brackets and comma “(129),” in the eighth line of sub-clause (x) thereof the number, brackets and comma “(129A),”.
