THE COTTON ORDINANCE

(CAP. 362)

ORDER

Made under section 7 (1)

THE COTTON (UPROOTING AND BURNING) ORDER, 1962

1. This Order may be cited as the Cotton (Uprooting and Burning) Order, 1962.

2. Every person possessing or having control over any cotton plants, cotton residues or cotton refuse in or near any cotton field in any of the areas specified in the first column of the Schedule hereto shall uproot and burn such cotton plants and cotton residues and burn such cotton refuse before the respective dates set out in the second column of the said Schedule.

3. Nothing in this Order shall apply to cotton plants planted in any of the areas specified in the first column of the Schedule hereto after the respective dates set out in the second column of the said Schedule or to the cotton residues and refuse thereof.
