THE DAR ES SALAAM CITY (TAXICAB) (AMENDMENT) BY-LAWS, 1965

1. These By-laws may be cited as the Dar es Salaam City (Taxicab) Title (Amendment) By-laws, 1965, and shall be read as one with the Dar es Salaam Municipality (Taxicab) By-laws, 1958.

2. By-law No. 16 of the Dar es Salaam Municipality (Taxicab) By-laws, 1958, is hereby repealed and replaced by the following new by-law:—

16. Each of the several places specified in the following list and indicated as being a stand for taxicabs by a notice board erected on the site by the Council shall be a stand for such number of taxicabs as are specified in the list:—

Place	No. of Taxis
(a) South side of Azikiwe Street, between Azania Front and City Drive	9
(b) North-west approach road to Customs Baggage Room	14
(c) Mnazi Mmoja fronting North side of Uhuru Street ...	30
(d) Msimbazi Street, South side of the junction with Lindi Street, along the West side	8
(e) Uhuru Street, North side, fronting Amana Cinema ...	6
(f) Narungombe Street, Kariakoo, South side (Pombe Market frontage)	12
(g) Morogoro Road, Tanganyika Legion Premises ...	6
(h) Railway Street, South-west side (Railway Station fore-court)	2

Made under section 5 (1)

THE PROVIDENT FUND (KASULU DISTRICT COUNCIL) REGULATIONS,
1965

1. These Regulations may be cited as the Provident Fund (Kasulu District Council) Regulations, 1965.

2. In these Regulations—

“The Commission” means the Local Government Service Commission;

“the Council” means the Kasulu District Council;

“the principal Regulations” means the Provident Fund (Local Authorities) Regulations, as amended from time to time;

“the Scheme” means the Local Government Service Scheme.
