ORDER

Under section 2

THE TRANSFER OF POWERS (AGRICULTURAL PRODUCTS (CONTROL AND MARKETING) ACT, 1962) (AMENDMENT) ORDER, 1965

1. This Order may be cited as the Transfer of Powers (Agricultural Products (Control and Marketing) Act, 1962) (Amendment) Order, 1965.

2. Paragraph 2 of the Transfer of Powers (Agricultural Products) (Control and Marketing) Act, 1962, Order, 1964, is hereby amended by deleting—

- (a) the words and commas beginning with “and the Tanganyika Board” and ending with the words and figures “Order, 1963,” where they occur in lines 7 and 8 thereof; and
- (b) by deleting the margination “G.N. 1962 No. 177”.

AGREEMENT

*Amendment to the Constitution of the Organization published under
section 2 (2)*

EAST AFRICAN COMMON SERVICES ORGANIZATION (AMENDMENT) (No. 3)
AGREEMENT, 1964

By an Agreement, to be cited as the East African Common Services Organization (Amendment) (No. 3) Agreement, 1964, made between the Government of the United Republic of Tanganyika and Zanzibar, the Government of Uganda and the Government of Kenya, the Constitution of the Organization is amended in the following respect with effect from the twenty-sixth day of April, 1964: —

Declaration of Holding Ripe for Development

There shall be added, immediately below paragraph 1 of Article 33B, the following new paragraph: —

“1A. For the avoidance of doubt it is hereby declared in relation to the United Republic of Tanganyika and Zanzibar that the reference to the Courts of each Territory in paragraph 1 of this Article shall be construed as a reference to any Court established by law in the United Republic of Tanganyika and Zanzibar, or any part thereof, and the reference in the said paragraph to any law in force in such Territory shall be construed as including a reference to any law in force in any part of the United Republic of Tanganyika and Zanzibar.”.
