AMENDING THE INSTRUMENT ESTABLISHING THE
MWANZA TOWN COUNCIL

Under section 10 (1)

THE LOCAL GOVERNMENT (MWANZA TOWN COUNCIL) AMENDING
INSTRUMENT, 1965

WHEREAS the Member for Local Government in exercise of the powers conferred upon him by section 4 of the Local Government Ordinance (hereinafter called the Ordinance) and with the prior approval of the Legislative Council signified by resolution, on the second day of December, 1954, made an Instrument establishing the Mwanza Town Council, called the Local Government (Mwanza Town Council) Instrument, 1954:

AND WHEREAS it is considered desirable to amend the Local Government (Mwanza Town Council) Instrument in the manner hereinafter appearing:

NOW, THEREFORE, I, ISAAC MULLER BHOKE MUNANKA, Minister of State (Regional Administration), in exercise of the powers conferred upon me by sub-section (1) of section 10 of the Ordinance, after consultation with the Mwanza Town Council, do hereby make the following Amending Instrument: —

1. This Instrument may be cited as the Local Government (Mwanza Town Council) Amending Instrument, 1965 and shall be read as one with the Local Government (Mwanza Town Council) Instrument, 1954, as amended from time to time (hereinafter referred to as the principal Instrument).
