THE EXCISE (MANAGEMENT AND TARIFF) (REMISSION OF FIVE MOTOR VEHICLES FOR USAID - AFYA YANGU PROJECT) (M/S DELOITTE CONSULTING LIMITED), ORDER 2025

Citation

1. This Order may be cited as the Excise (Management and Tariff) (Remission of Five Motor vehicles for USAID - Afya Yangu Project) (M/S Deloitte Consulting Limited) Order, 2025 and shall be deemed to have come into operation on 11th day of October 2024.

Remission

2. Subject to the conditions specified in paragraph 3, and any other conditions as may be specified by the Commissioner General of Tanzania Revenue Authority, the whole of excise duty payable on five motor vehicles specified in the Schedule, imported or purchased locally prior to clearance through customs by or on behalf of M/S Deloitte Consulting Limited to be used solely in the USAID - Afya Yangu Project, is hereby remitted.

Conditions

3. The remission granted under this Order shall cease to have effect and the excise duty shall become due and payable as if this Order had not been made if the said motor vehicles are used for other purposes or are transferred, sold or disposed of in any way to another
