THE LOCAL LIQUOR ORDINANCE

(CAP. 77)

BY-LAWS

Under section 56

THE NJOMBE DISTRICT COUNCIL (LOCAL LIQUOR) BY-LAWS, 1965

1. These By-laws may be cited as the Njombe District Council (Local Liquor) By-laws, 1965.

2. The fees chargeable in the area of jurisdiction of the Njombe District Council for licences to manufacture and sell local liquor shall be as follows: —

3. No fee shall be chargeable for a permit to manufacture local liquor for private consumption on premises specified in the permit by the owner of such premises and his friends and not for the purpose of sale.

4. All licences and permits issued by the Licensing Officer shall be in the form set out in the Schedule hereto.

5. No local liquor shall be sold before the hour of 12.00 noon or after 6.00 p.m. on Mondays to Saturdays and before 10.00 a.m. or after 6.00 p.m. on Sundays.

6. The Njombe African District Council (Drinking and Sale of Native Liquor) Rules, 1961 are hereby revoked.
