(Act No. 10 OF 1958)

THE EAST AFRICAN INCOME TAX (NATIONAL SAVINGS BONDS: FIRST ISSUE) (TANZANIA) (EXEMPTION) ORDER, 1965

1. This Order may be cited as the East African Income Tax (National Savings Bonds: First Issue) (Tanzania) (Exemption) Order, 1965.

2. The income of the National Savings Bonds, First Issue, which accrues in or is derived from Tanzania is hereby exempted from income tax.

(ACT No. 10 OF 1958)

In exercise of the powers conferred by section 12 (2) of the East African Income Tax (Management) Act, 1958, the President of the United Republic of Tanzania, with the approval of the National Assembly thereof, hereby makes the following Order:—

THE EAST AFRICAN INCOME TAX (MANAGEMENT) (EXEMPTION) (COLLEGE OF AFRICAN WILDLIFE MANAGEMENT) ORDER, 1965

1. This Order may be cited as the East African Income Tax (Management) (Exemption) (College of African Wildlife Management) Order, 1965.

2. The income of the Governing Body of the College of African Wildlife Management established by the College of Wildlife Management Act, 1964, of Tanzania, shall be exempt from income tax.
