ALTERATION OF POLLING DISTRICTS

The division of constituencies into the Polling Districts listed in the Schedule to Government Notice No. 66 published on 20th February, 1960 is hereby altered in the following manner:—

G.N. No. 96 (contd.)

(a) SONGEA CONSTITUENCY

Delete the description of the area of Polling District No. 1 Songea and substitute therefor the following:—

1. The Songea Township.

(b) IRAMBA CONSTITUENCY

Delete the following:—

5. Ulemo 5. The Sub-Chief of Ulemo".
- and renumber Polling Districts numbers 6 to 13 as numbers 5 to 12 respectively.

(c) MBEYA CONSTITUENCY

- (i) Delete the words "Headman of Itete" from the description of the area of Polling District No. 21 Uguruka and substitute therefor the words "Headmen of Itete and Ihango".
- (ii) Delete the words "Headman of Itete" from the description of the area of Polling District No. 22 Itete and substitute therefor the words "Headmen of Itete and Ihango".
- (iii) Delete the words "Headman of Gua" from the description of the area of Polling District No. 27 Gua and substitute therefor the words "Headmen of Gua and Manda".
- (iv) Delete the words "Headman of Gua" from the description of the area of Polling District No. 28 Lukwati and substitute therefor the words "Headmen of Gua and Manda".

(d) LUSHOTO CONSTITUENCY

- (i) Delete the word "Shashui" from the description of the area of Polling District No. 64 Kibaoni and substitute therefor the word "Hundu".
- (ii) Delete the whole of the description of the area of Polling District No. 65 Kizara and substitute therefor—"65. The areas of jurisdiction of the Village Headman of Hundu to the east of Lutindi Forest Reserve and the Village Headman of Shashui".

"12. The Chief of Mgori excluding that part under the jurisdiction of the Sub-Chief of Ngimu".

(i) KILWA CONSTITUENCY

Delete the description of the area of Polling District No. 11 Kizimbani and substitute therefor the following:—

"11. The Native Authority of Kizimbani excluding those parts under the jurisdiction of the Native Authorities of Likawage and Nambunju".

(j) TANGA COAST CONSTITUENCY

(i) Delete the description of the area of Polling District No. 20 Kwafungo and substitute therefor the following:—

“20. The Village Headmen of Kwafungo and Bagamoyo”.

(ii) Delete the names and areas of Polling Districts Nos. 62 to 67 inclusive and substitute therefor the following:—
